TRANSPARENCY ACT



A new Norwegian law, the Transparency Act, became effective from July 2022. This Act requires companies to make sure human rights and decent working conditions are respected in their operations and supply chains.

The Transparency Act also requires companies to conduct human rights due diligence activities, including business partners. This means that Canes AS need to take steps to identify, address, prevent and limit violations of human rights or decent working conditions - whether potential or actual impacts. Required activites include implementing the appropriate policies, processes such as risk assessments, and providing or cooperating with efforts to provide remedy for any violations.

The Transparency Act also requires companies to report on all of these activites and make this information available on their corporate websites, promoting transparency.

Annual Due Diligence Assessments

- Canes will carry out annual due diligence assessments for its own business as part of the annual Compliance Assessment in accordance with the Transparency Act.
- As a certified Eco-lighthouse company, we have worked specifically with sustainability in areas such as the working environment, waste management, energy use, purchasing and transport since 2018.

Risk Assessments

- Self-evaluation form submitted by new suppliers must be approved/rejected when submitted by the purchasing manager and/or product manager. All suppliers allocated as A-supplier must be reapproved every 3 years.
- All new suppliers must sign that they comply with all our requirements specified in our Code of Conduct and Supplier Code of Conduct.
- At our request, all suppliers must prove that their products are RoHS/REACH compliant.

Anchoring responsibility and level of ambition

- Canes wants to contribute positively to promoting respect for human rights and employee rights. We work systematically to incorporate the human rights aspect into our operations and towards our partners. We do this, among other things, by giving our employees decent wages and regulated working hours. We do not accept any violation of basic human rights internally or externally. We work to uncover whether Canes contributes to potential violations of human rights and decent working conditions, and we exercise a high degree of caution when we have operations or business partners in areas where human rights and worker rights are weaker. In cases where deviations are discovered, we will work actively to rectify them.
- The CEO has the ultimate responsibility for ensuring that the law is met and delegates mandates to the relevant executive employees.
- QA & Continuous Improvement Manager is responsible for practical implementation and coordination, including identification of risks/deviations, measures, and follow-up effects. If appropriate, this responsibility is delegated to purchasing and/or product manager.
- Responsibility, mandate and guidelines are anchored in the board.

Risk Assessments - Method

- The leadership team has carried out risk analysis work where all relevant types of stakeholders for Canes have been assessed.
- In Norway, we have concluded that the risk of violations of human rights or working conditions is low. For our own employees, we have conducted our annual business survey that show a high degree of satisfaction with their own working situation.
- Suppliers of Canes have recieved *Canes Supplier Transparency Questionnaire*, which includes provisions in the Transparency Act in addition to certain industry-specific topics.
- We have mapped which countries of origin our approved suppliers come from. We have used different indexes for this assessment. The countries are assessed in the following categories, High risk, Medium risk, Moderate risk and Low risk.
 - UN Human Development Index (HDI)
 - Global Slavery Index (GSI)
 - Transparency International Index (CPI)
 - Environmental Performance Index (EPI)
 - Global Rights Index (GRI)

Scope of Work

- We have had commercial relationships with 150 suppliers in 2024.
 - o 99% of all suppliers is located in Europe
 - Approx. 85% of revenue is distributed from our top 30 suppliers (strategic suppliers) which indicates approx.
 20% of all suppliers
 - Strategic suppliers are all located in Europe





Risk Assessments - Results

- In the first iteration of our risk assessment, based on country and indexes,
 7 suppliers were found to remain assesses as moderate risk. These suppliers have production in Belgium, Poland and Greece.
- Second iteration is based on the answers from Canes Supplier
 Transparency Questionnaire. All 7 suppliers have been re-assessed to low
 risk due to their policies, certificates and on-going processes.

Risk of Negative Consequences

- Mapping and risk classification have not identified actual negative consequences or significant risks of negative impact of human rights through the overall risk assessment.
- Canes states that we operates in an industry and at locations where there
 is a low risk of when it comes to violations of privacy, business conduct,
 HSE, human rights and working conditions.
