The following information provides an update on the funding made available by Congress through the Higher Education Emergency Relief Fund established by the CARES (Coronavirus Aid, Relief and Economic Security) Act.

(July 7, 2020) — In compliance with Section 18004(e) of the CARES Act, Christian Brothers University is pleased to provide the following information to the public. We will update this information every 45 days:

- 1. An acknowledgement that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.

 The grant application (GRANT13072605) for the 50% student portion (\$800,345) was submitted on 4/15/2020. The Department of Education accepted and awarded the grant (P425E201850) on 4/24/2020.

 The grant application (GRANT13079216) for the University 50% portion (\$800,345) was submitted on 4/24/2020. The Department of Education accepted and awarded the grant (P425F200509) on 5/4/2020.

 In total, the University has received \$1,600,690 from the Department of Education pursuant to the institution's Certification and Agreements for Higher Education Emergency Relief Fund.
- 3. The total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)(1) of the CARES Act as of the date of submission.

The University will distribute \$800,345 to students for expenses related to the disruption of campus operations due to coronavirus (including eligible expenses under a student's cost of attendance such as food, housing, course materials, technology, health care, and child care). As of the date of this notice \$751,000 have been distributed to students.

 As of the date of this notice, 1,150 students have received an Emergency Financial Aid Grant to students under Section 18004(a)(1) of the CARES Act.

 The University will use two methods to determine which students receive Emergency Financial Aid Grants and how much they would receive under Section 18004(a)(1) of the CARES Act.

 The general distribution All eligible students will receive between \$250 and \$1,200 based on their Expected Family Contribution (EFC) as determined by the FAFSA the student currently has on file. If a student does not have a current FAFSA on file they are not eligible for this general distribution. Grant application distribution, eligible students will receive distributions based solely on need as determined by the CBU grant distribution governance committee.
