



# COVID-19 Quarantine Protocol & Expectations

## Christian Brothers University Campus Suite

In accordance with the Center for Disease Control (CDC), **quarantine** is necessary when you have been in close contact (within 6 feet of someone for a total of 15 minutes or more) with someone who has COVID-19, unless you have been fully vaccinated. People who are fully vaccinated do NOT need to quarantine after contact with someone who had COVID-19 unless they have symptoms. Quarantine helps prevent spread of disease that can occur before a person knows they are sick or if they are infected with the virus without feeling symptoms. People in quarantine should stay home, separate themselves from others, monitor their health, and follow directions from their state or local health department.

Christian Brothers University (CBU) is following the guidelines outlined by the CDC and the Shelby County Health Department. As such, your quarantine period will last a period of seven to ten (7 to 10) days from your date of last contact to a COVID positive individual. In this instance, it is imperative that you stay in the suite that CBU has assigned you at this time.

Bettye Durham, Coordinator of COVID Operations, will be your primary point of contact during your quarantine period. Please add her number to your phone. If you find that you need anything during your stay, contact Bettye Durham. Additionally, you can call Student Development & Campus Life (SDCL) at (901) 321-3531 or Campus Safety at (901) 321-3550. If maintenance issues arise during this time, contact Bettye Durham **and** Campus Safety.

### **DO NOT LEAVE THE SUITE UNLESS FOR A MEDICAL EMERGENCY.**

#### **During your time in quarantine, Christian Brothers University expects the following:**

- **Do not leave the suite that you have been assigned.** Also, no one is allowed to enter your suite or visit without prior authorization from Christian Brothers University staff. This is for your safety and the safety of others. If you decide to return to your **home** to complete your quarantine, please notify Bettye Durham or the Office of Student Development and Campus Life.
- CBU will make welfare checks to check your physical and mental well-being during your time in quarantine. Make every effort to answer your phone or the door when a CBU staff member calls or visits. PLEASE REMEMBER TO WEAR YOUR MASK WHEN INTERACTING IN PERSON WITH CBU STAFF OR PERSONNEL
- If you are **symptomatic and have been tested**, you must quarantine until test results are received which could be a period of 24-48 hours. If you are a close contact, you will be required to quarantine for a period of 7-10 days, beginning at the last date of contact to a COVID positive individual. Between days three and five of your quarantine, a COVID test will be scheduled for you. Once an off-campus location comes available, you will be moved to complete your quarantine at an off-campus location.
- While you are in partial or complete quarantine, you will be provided meals via Aramark. These meals will be delivered twice daily by CBU personnel. Please answer the door when the meals arrive.
