To apply for an Initial CPA license in Tennessee, candidates must earn a baccalaureate degree from an accredited college or university and obtain a total of 150 semester hours of education. Education must include 30 semester hours in accounting (24 of which must be in upper division courses) and 24 semester hours in business courses. Completing both the BS in Accounting and Master of Accountancy programs at CBU meets the educational requirements for Tennessee. The candidate must then pass the Uniform CPA Examination, score 90% or better on an ethics examination given by the American Institute of Certified Public Accountants (AICPA), and complete one year of experience in accounting acceptable to the Board.
