### Affidavit of Sponsorship

The U.S. Citizenship and Immigration Services (USCIS) require that each student shows they have sufficient funds to cover their tuition and living expenses during the period of intended study. You must show you have the funds available for the first year and resources for the duration of your stay. In cases where funding is being provided by anyone other than the student, it is necessary for the sponsoring party or parties to each complete the following form indicating their commitment to supporting the student.

A CERTIFICATE OF ELIGIBILITY (UCIS Form I-20) will not be authorized until this form is completed and returned to Christian Brothers University.

### Sponsor Agreement

1. I agree to pay all expenses for the student. My sponsorship includes, but is not limited to, tuition, fees, books, health insurance, room and board, and travel expenses. I have submitted financial statement(s) to show that I have sufficient financial resources to cover the first academic year of such expenses. For an undergraduate student, that is at least \$29,000 USD.
2. I attest that my sponsorship is not provided only for admission requirements, for the Form I-20/DS-2019, or for a U.S. visa application. I have the honest intention to provide this sponsorship as soon as the student arrives in the United States.
3. I understand that full-time enrollment is the most important responsibility of an F-1 student and failure to maintain full-time enrollment will cause the student to lose F-1 status within days. Payments must be made according to University deadlines to avoid disenrollment for failure to pay.
4. I understand that my sponsorship must continue for the duration of the student's studies, which will be a period of multiple years.
