The organization is comprised of a multi-generational and international roster of the finest chamber musicians, enabling us to present chamber music of every instrumentation, style, and period. Our concerts feature thoughtfully curated performances of masterworks and important works by a diverse range of contemporary and living composers. CMS also conducts outreach to diverse audiences in New York City, and provides unparalleled career building opportunities for outstanding early-career musicians.

Touring: Each season CMS pursues a vigorous touring schedule across the United States, North and South America, Europe and Asia.
