

Terms and Conditions

Promotion Description: The 'Parkside Town Commons Step into Fall Contest' ("Sweepstakes") begins on 09/14/2020 at 12:00 AM (Eastern Time (US & Canada)) and ends on 09/30/2020 at 11:59 PM (Eastern Time (US & Canada)) (the "Promotion Period"). By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Parkside Town Commons ("Sponsor"), which shall be final and binding in all respects. Sponsor is responsible for the collection, submission or processing of Entries and the overall administration of the giveaway.
