

Terms and Conditions

Promotion Description: The 'Delray Marketplace Oh, What Fun! Contest' ("Sweepstakes") begins on 12/8/2020 at 12:00 AM (Eastern Time (US & Canada)) and ends on 12/21/2020 at 11:59 PM (Eastern Time (US & Canada)) (the "Promotion Period"). By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Delray Marketplace ("Sponsor"), which shall be final and binding in all respects. Sponsor is responsible for the collection, submission or processing of Entries and the overall administration of the giveaway. Eligibility: Open to residents of the Delray Beach, Florida area. Void where prohibited or restricted by law.
