

Terms and Conditions

Promotion Description: The 'Parkside Town Commons Give Thanks Contest' ("Sweepstakes") begins on 11/3/2023 at 12:00 AM (Eastern Time (US & Canada)) and ends on 11/27/2023 at 11:59 PM (Eastern Time (US & Canada)) (the "Promotion Period"). By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Parkside Town Commons ("Sponsor"), which shall be final and binding in all respects. Sponsor is responsible for the collection, submission or processing of Entries and the overall administration of the giveaway. Entrants should look solely to Sponsor with any questions, comments or problems related to the Sweepstakes.

Eligibility: Open to residents of the Cary, NC area. Void where prohibited or restricted by law.
