

Terms and Conditions

Promotion Description: The 'Delray Marketplace We Love Our Customers Contest' ("Sweepstakes") begins on 01/26/24 at 12:00 AM (Eastern Time (US & Canada)) and ends on 02/14/24 at 11:59 PM (Eastern Time (US & Canada)) (the "Promotion Period"). By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Delray Marketplace ("Sponsor"), which shall be final and binding in all respects. Sponsor is responsible for the collection, submission or processing of Entries and the overall administration of the giveaway. Entrants should look solely to Sponsor with any questions, comments or problems related to the Sweepstakes.

Eligibility: Open to residents of the Delray Beach, Florida area. Void where prohibited or restricted by law.
