

Terms and Conditions

Promotion Description: The 'Eddy Street Commons Celebrate Mom Contest' ("Sweepstakes") begins on 4/11/25 at 12:00 AM (Eastern Time (US & Canada)) and ends on 5/12/25 at 11:59 PM (Eastern Time (US & Canada)) (the "Promotion Period"). By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Eddy Street Commons ("Sponsor"), which shall be final and binding in all respects. Sponsor is responsible for the collection, submission or processing of Entries and the overall administration of the giveaway.
