July 2023 – Feedback analysis report

Section 1

Purpose of this report

The purpose of this report is to provide an overview of and insight into the opinions of people who have shared feedback on the Crookes and Walkley Active Neighbourhood via a survey which was available between 7 June 2023 and 28 June 2023.

The survey was created after the initial trial period for the Experimental Traffic Regulation Order had ended. It was designed to gain insight into people's views of the Active Neighbourhood now that they have had the opportunity to experience the scheme after a trial period of the measures has been completed.

The survey was hosted on the Connecting Sheffield website. This website brings together a number of Sheffield City Council projects focused on improving public transport, cycling and walking in Sheffield. The Crookes and Walkley Active Neighbourhood pages on this website have acted as an online resource hub for the project, and include details of the scheme, information on how to get in touch, and regular updates. Respondents who were not able to complete the survey online were able to contact the Connecting Sheffield information phoneline to either provide their feedback over the phone or to request a paper copy of the survey be posted out to them.

The analysis presented in this report aims to:

- provide a clear, accurate and meaningful representation of the feedback that has been submitted
- generate insights into important themes arising from feedback
- support and inform the decision-making process about the Crookes and Walkley Active Neighbourhood.

The purpose of the perception survey is to build on the feedback received as part of both the initial concept survey and subsequent ETRO feedback received. Taken collectively, each opportunity for feedback provides a view on which aspects of the scheme have had a positive and negative impact to help inform next steps after the conclusion of the trial of the scheme,

Background

Through funding granted from the government's Active Travel Fund (ATF), Sheffield City Council has an opportunity to deliver a series of sustainable travel projects within Sheffield.

The **Connecting Sheffield: Crookes and Walkley Active Neighbourhood** scheme was one of three ATF schemes to be brought forward under Connecting Sheffield. An initial concept consultation was held in summer 2021, where 66% of respondents expressed their support for an Active Neighbourhood in their area.

Following this concept consultation, an Experimental Traffic Regulation Order (ETRO) was advertised on 14 April 2022 in advance of changes being made to create the Crookes and Walkley Active Neighbourhood.

Through the ETRO mechanism, changes to an area are implemented on a trial basis and the opportunity for the public to comment and provide feedback remains open during a six-month period of statutory consultation which can be extended up to 18 months.

Sheffield City Council asked local people to share their feedback on the scheme during this trial period so that it could understand how the Active Neighbourhood was working and make any changes where necessary.



The six-month statutory consultation period for this ETRO ran from 25 April 2022 until 25 October 2022. Sheffield City Council experienced unexpected delays in putting some of the planned measures in place which meant that some measures were not put in until November 2022, after the end of the statutory consultation period. As this meant that local people had not been able to experience how the Active Neighbourhood worked as a whole, the period for accepting comments on the scheme was extended until 3 March 2023, with the extension being communicated to the local community. A report was produced to present the feedback received during the trial period in May 2023.

Creating the Active Neighbourhood

On 25 May 2022, the first measures were implemented to create the Active Neighbourhood via an 'Experimental Traffic Regulation Order' (ETRO).

The plans originally included:

- 13 proposed road-point closures that restrict vehicular through-route access at the mid-point of a road while still allowing access at either end (two on Springvale Road at the junctions with Cobden View Road and Western Road; two on Newent Lane; two on Slinn Street; two on Matlock Road - one at the junction of Pickmere Road and Sackville Road and another at the junction of Sackville Road and Romsdal Road; one on Learnington Street; one on Fir Street; and one on Highton Street).
- Five one-way restrictions (two at either end of Greenhow Street; one on Heavygate Avenue; one on Springvale Road; and one on Mona Avenue).
- Three controlled pedestrian crossings (one on Crookes; one on Heavygate Road; and one on Crookesmoor Road).
- One School Street.

Responding to feedback from local residents and businesses throughout the trial period, Sheffield City Council made some changes to the Active Neighbourhood, including:

- Removing the closure at the junction of Sackville Road and Romsdal Road as the closure at the junction of Sackville Road and Pickmere Road reduced through-traffic sufficiently.
- Removing the closure on Slinn Street to retain access to the church and pub, and to provide an alternative route during snowy periods.
- Repositioning the closure on Newent Lane to allow easier refuse collection.
- Removing the closure at the eastern junction of Matlock Road and Heavygate Road to maintain a car access route between Crookes and Walkley.
- Removing the diagonal closures on Springvale Road at the junctions with Cobden View Road and Western Road due to a lack of space for vehicles to manoeuvre.
- Restoring the double yellow lines on the corners of Western Road and Cobden View Road to their original lengths as they were no longer necessary following the removal of the diagonal closures.
- Removing the one-way restriction on Springvale Road to reduce the impact of displaced traffic using Melbourn Road.

The map included in Appendix 1 shows the scheme as it currently stands.

Publicising the survey

On 7 June 2023, the survey was published on the Connecting Sheffield website on the **Crookes and Walkley Active Neighbourhood: Latest Updates** page where the public were able to access a live link. Appendix 2 shows a screenshot of the webpage.

In May 2023, a leaflet was posted to 7,731 addresses in Crookes and Walkley, providing an update on the scheme and next steps, including confirmation that a survey would go live on the website. Those who were unable to



access the online survey were then able to request a posted copy of the survey by calling the freephone information line via the number which was provided on the leaflet.

On 8 June 2023, Sheffield City Council officers contacted local ward councillors for Crookes and Crosspool ward, Walkley ward and Broomhill and Sharrow Vale ward via email to communicate that the survey was live and to ask them to share via their social media platforms. In addition, on 7 June 2023, we contacted 110 key stakeholders directly via email and provided access to a live survey link.

On 14 June 2023 Sheffield City Council issued a Nextdoor post to publicise the survey online. Nextdoor is a discussion-style social media platform where members can post updates, polls, events, and ask for recommendations, as well as list items for sale. Sheffield City Council has their own Nextdoor account and page.

The scheme has been widely discussed on local neighbourhood Facebook pages, with the survey link being shared within groups by members of the public. Local ward councillors also shared details of the survey on their social media platforms including political party Facebook pages. Appendix 2 shows where surveys were publicised online.



Section 2

Response to the Crookes and Walkley Active Neighbourhood survey June 2023

In total, 335 people responded to the online survey during the feedback period between 7 June 2023 and 28 June 2023. In cases where respondents requested access to the survey in alternative formats, feedback was taken over the phone and inputted to an online survey on their behalf, or feedback received via Freepost was transcribed onto an online feedback form. This feedback is included in the chart looking at all feedback below. In total, two surveys were submitted over the phone and two surveys were submitted in hardcopy format.




Figure 1: Pie chart showing response to the question: What is your connection to the area?

The number of submissions received according to each category is broken down below in Table 1 and Figure 1.

Resident feedback

In total, 292 out of 335 respondents categorised themselves as residents within the area. Respondents were asked to provide the first part of their postcode in order to help us further understand the location of respondents. Of those respondents identifying themselves as residents, 291 out of 292 provided a postcode linked to the Crookes and Walkley area.

The feedback received from residents is presented below.

Closed question responses

Do you live in Crookes or Walkley?

Of the 292 respondents who identified themselves as residents living in the Crookes and Walkley area, 175 respondents (60%) selected that they lived in Crookes whilst 117 respondents (40%) identified themselves as living in Walkley.




Figure 2: Pie chart showing response to the question: Do you live in Crookes or Walkley?

How long have you lived in Crookes or Walkley?

Of the 292 respondents who identified themselves as residents in the Crookes and Walkley area, 241 respondents (82%) selected that they had lived in the area for longer than five years. 27 respondents (9%) selected that they had lived in Crookes or Walkley for 1-2 years whilst 16 respondents (5%) selected that they had lived in Crookes or Walkley for 2-5 years.




Figure 3: Pie chart showing response to the question: How long have you lived in Crookes or Walkley

What change, if any, have you noticed in the following since the implementation of the Crookes and Walkley Active Neighbourhood in May 2022?

284 respondents were asked this question, as residents who had lived in the area for longer than one year. Of these 284 respondents, the majority selected that they had noticed no change in the number of people walking, the number of people cycling and traffic speeds. 175 respondents (61% of question responses) selected that they had noticed that the amount of traffic had either greatly increased or increased following the implementation of Active Neighbourhood measures.




Figure 4: Chart showing response to the question: What change, if any, have you noticed in the following since the implementation of the Crookes and Walkley Active Neighbourhood Scheme in May 2022

Before the Active Neighbourhood was put in place, how did you feel about the proposals?

284 respondents were asked this question, as residents who had lived in the area for longer than one year. The majority of respondents (77 respondents or 27%) selected that before the Active Neighbourhood was put in place, they felt very negatively about the proposals. Figure 6 shows the response to this question as a comparison between respondents identifying themselves as Crookes residents or as Walkley residents.




Figure 5: Pie chart showing response to the question: Before the Active Neighbourhood was put in place, how did you feel about the proposals?




Figure 6: Chart showing response by respondent location to the question: Before the Active Neighbourhood was put in place, how did you feel about the proposals?

Overall, how do you feel about the Active Neighbourhood now it is in place?

All respondents who identified themselves as residents were asked this question. The majority of residents (160 respondents or 55%) said that they feel very negatively about the Active Neighbourhood now it is in place. According to survey responses, the proportion of respondents feeling very negatively about the scheme has increased since the Active Neighbourhood measures were put in place. Figure 8 shows the responses to this question as a comparison between respondents identifying themselves as Crookes residents or as Walkley residents.




Figure 7: Pie chart showing response to the question: Overall, how do you feel about the Active Neighbourhood now it is in place?




Figure 8: Chart showing response by respondent location to the question: Overall, how do you feel about the Active Neighbourhood now it is in place?

Now the Active Neighbourhood is in place, how do you think it has impacted the following?




Figure 9: Chart showing response to the question: Now the Active Neighbourhood is in place, how do you think it has impacted the following?




Figure 10: Chart showing response to the question: Now the Active Neighbourhood is in place, how do you think it has impacted the following?






Figure 11: Chart showing response to the question: Now the Active Neighbourhood is in place, how do you think it has impacted the following?




Figure 12: Chart showing response to the question: Now the Active Neighbourhood is in place, how do you think it has impacted the following?

Due to the amount of data provided in response to this question, responses have been grouped into separate charts based on relevant categories. Table 8 shows response to the question including all themes, whilst figures 9,10, 11 and 12 display the response to this question in separate charts, each focusing on a specific theme.

In general, the majority of respondents selected that they thought the Active Neighbourhood had had no impact on the number of people walking, the number of people cycling, walking safety, cycling safety, air quality and noise.

The majority of respondents also selected that they thought the Active Neighbourhood had very negatively impacted parking, congestion, through-traffic, traffic speed, journey times, local businesses, visitors and accessibility e.g. disabled access.

286 respondents answered this question. The majority of respondents selected that the amount that they walk, cycle, take the bus and use a private vehicle had stayed the same.




Figure 13: Chart showing response to the question: Thinking about how you get around, has this changed since the Active Neighbourhood was put in place?

How often, if at all, do you walk or cycle around the local area?

290 respondents answered this question in relation to walking, and the majority of these respondents (170 respondents or 59%) selected that they walked around the local area on a daily basis. In relation to cycling, 262 respondents provided a response and the majority of these (170 respondents or 65%) selected that they never cycle around the local area.




Figure 14: Chart showing response to the question: How often, if at all, do you walk or cycle around the local area?




Figure 15: Chart showing response to the question: Do you think any of the following measures would encourage local residents to walk, cycle or use public transport?

The option 'None of the above' refers to all measures listed in Figure 15 and Table 12.

How do you think the Active Neighbourhood has impacted children's safety when they walk or cycle around the local area without adult supervision?

292 respondents answered this question. The majority of respondents (41% in relation to walking and 44% in relation to cycling) selected that they thought the Active Neighbourhood had had no impact on children's safety when walking and cycling around the local area.




Figure 16: Chart showing response to the question: How do you think the Active Neighbourhood has impacted children's safety when they walk or cycle around the local area without adult supervision?

Would you support keeping the Active Neighbourhood scheme in place?

292 residents answered this question, with the majority (63% or 183 respondents) selecting that they do not support keeping the Active Neighbourhood scheme in place. 18% of respondents (54) selected that they would support keeping the Active Neighbourhood scheme in place but only if certain things were changed. 15% of respondents (43) selected that they completely support keeping the Active Neighbourhood in place.




Figure 17: Pie chart showing response to the question: Would you support keeping the Active Neighbourhood scheme in place?




Figure 18: Chart showing comparison between Crookes residents and Walkley residents response to the question: Would you support keeping the Active Neighbourhood scheme in place?

Residents: open question feedback response

Can you tell us what changes you would suggest?

Residents were asked to provide further feedback if they selected the following option in response to the previous question: 'Would you support keeping the Active Neighbourhood scheme in place?':

'Yes, but only if certain things were changed'.

Respondents were then asked to let us know what changes they would suggest. These responses are presented below in the following tables, grouped by theme.

General criticism of the scheme

Total responses: 15

5 respondents criticised the implementation of the scheme, suggesting it was implemented inefficiently and ineffectively.

3 respondents commented that the scheme has made some rat runs quieter whilst other roads have become busier.

3 respondents commented that the measures should be removed.

2 respondents commented that people are confused by restrictions on Greenhow Street.

1 respondent suggested that measures should be enforced more effectively.

1 respondent criticised the extended yellow lines on Western Road and Springvale Road.

General suggested additional measures

Total responses: 13

3 respondents commented that there is a need for improved public transport.

2 respondents suggested increased signage.

1 respondent requested that Greenhow Street is blocked.

1 respondent would like a bus gate part way along Crookes and South Roads, with resident exemption.

1 respondent requested additional measures to prevent pavement parking on South Road.

1 respondent commented that the scheme should filter as many streets as possible with through traffic restricted to main roads.

1 respondent commented that there is a need for improved street lighting.

1 respondent commented that there is a need for more pavements.

1 respondent suggested that implemented measures are added to Google Maps for navigation purposes.

1 respondent suggested that there is a double yellow line refuge implemented on School Road to allow cars to pass.

Suggested removal of implemented measures

Total responses: 8

3 respondents suggested removing all planters.

1 respondent suggested removing the road closures whilst maintaining the pedestrian crossings.

1 respondent suggested removing the planters from Sackville Road.

1 respondent suggested removing the closure on Fir Street as it seems redundant.

1 respondent suggested removing one-way restrictions on Greenhow Street since it is inaccessible to people with disabilities.

1 respondent suggested complete removal of any route diversions.

Suggested cycling measures

Total responses: 8

7 respondents requested additional cycle infrastructure such as cycle lanes and dedicated safe cycling space. 1 respondent requested increased cycle storage solutions.



Traffic speeds

Total responses: 6

- 3 respondents made a general request for traffic calming measures in the area.
- 1 respondent requested that Heavygate Road becomes a 20mph zone.
- 1 respondent commented that traffic speeding in the area is a problem, and this deters them from cycling.
- 1 respondent commented that cars do not adhere to 20mph speed limits.

Congestion concerns

Total responses: 5

2 respondents commented that congestion on main roads has increased.

1 respondent suggested that the number of road closures is reduced to reduce the concentration of traffic on narrow streets.

- 1 respondent commented that the road closures increase traffic displacement and increase journey times.
- 1 respondent commented that measures have increased congestion on Heavygate Road.

Suggested introduction of one-way measures

Total responses: 4

1 respondent requested additional one-way restrictions on Walkley Road.

1 respondent requested additional one-way restrictions on Palm Street.

1 respondent requested additional one-way restrictions on Freedom Road.

1 respondent requested additional one-way restrictions in general.

Comments concerning School Street

Total responses: 3

1 respondent mentioned School Street as a good idea but stated that it is only partially policed.

1 respondent commented that the Learnington Street section is congested during school drop off and collection.

1 respondent commented that the School Street measure makes sense.

Comments regarding pedestrian crossings *Total responses: 4*

2 respondents commented that the pedestrian crossings have positively impacted the area.

1 respondent commented that the zebra crossings near Northfield Avenue should be traffic light controlled, to ensure drivers slow down to approach.

1 respondent requested additional pedestrian crossings.

Negative comments regarding pedestrian crossings

Total responses: 2

1 respondent commented that the pedestrian crossings should be permanent fixtures since the generators are unreliable.

1 respondent suggested moving the pedestrian crossing at the top of Heavygate Avenue lower down to the bus stop on Heavygate Road since its current placement makes turning left on to Heavygate Road dangerous.

1 respondent commented that access to businesses on South Road is more difficult. 1 respondent commented about access at St Vincent's church, requesting that normal access is restored.

General positive mention of the scheme

Total responses: 2

1 respondent stated that they support the introduction of the scheme.

1 respondent expressed positive sentiment towards the scheme in theory/principle.



Business owner/manager feedback

In total, 10 out of 335 respondents categorised themselves as business owners or managers within the area. Respondents were asked to provide the first part of their postcode in order to help us further understand the location of respondents. The majority of responses (80% or 8 responses) were from business owners or managers based in Walkley whilst 20% of responses (2) were based in Crookes.




Figure 19: Pie chart showing response to the question: Where is your business based?




Figure 20: Pie chart showing response to the question: What is your role in the business/organisation?




Figure 21: Pie chart showing response to the question: How long have you worked in a business in the Crookes and Walkley area?




Figure 22: Chart showing response to the question: During the last year of trading, what impact do you think the Active Neighbourhood has had on footfall to your business?




Figure 23: Chart showing response to the question: Now that the Active Neighbourhood is in place, have you noticed a changed in any of the following?




Figure 24: Chart showing response to the question: How do you think the Active Neighbourhood has impacted: The local area in general, businesses in the local area and your business specifically?




Figure 25: Chart showing response to the question: Now the Active Neighbourhood is in place, how do you think it has impacted the following?




Figure 26: Chart showing response to the question: Now the Active Neighbourhood is in place, how do you think it has impacted the following?






Figure 27: Chart showing response to the question: Now the Active Neighbourhood is in place, how do you think it has impacted the following?

Due to the amount of data provided in response to this question, responses have been grouped into separate charts based on relevant categories. Table 21 shows response to the question including all themes, whilst figures 24,25, 26 and 27 display the response to this question in separate charts, each focusing on a specific theme.

In general, the majority of respondents selected that they thought the Active Neighbourhood had had no impact on the number of people walking, the number of people cycling, walking safety and cycling safety.




Figure 28: Chart showing response to the question: Now the Active Neighbourhood is in place, how do you think it has impacted the following?




Figure 29: Chart showing response to the question: How do you think the majority of your visitors/customers travel to your organisation/business?




Figure 30: Chart showing response to the question: Would you support keeping the Active Neighbourhood scheme in place?




Figure 31: Chart showing response to the question by location of respondent: Would you support keeping the Active Neighbourhood in place?




Figure 33: Pie chart showing response to the question: Do you tend to visit Crookes or Walkley?




Figure 34: Pie chart showing response to the question: What is your main reason for visiting Crookes and/or Walkley?




Figure 35: Pie chart showing response to the question	n: How regularly do you visit the Crookes and Walkley area?




Figure 36: Pie chart showing response to the question: For how long have you been visiting the Crookes and Walkley area?




Figure 37: Chart showing response to the question: Have the following changed for you, now that the Active Neighbourhood is in place?




Figure 38: Chart showing response to the question: What is the main way that you travel to Crookes and/or Walkley?




Figure 39: Chart showing response to the question: When travelling to visit Crookes and/or Walkley, has your usage of the following methods of transport changed at all, now that the scheme is in place?




Figure 40: Pie chart showing response to the question: Overall, how do you feel about the Active Neighbourhood in Crookes and Walkley?




Figure 41: Pie chart showing response to the question: Would you support keeping the Active Neighbourhood in place?




Figure 42: Pie chart showing response to the question: What is your gender?




Figure 43: Pie chart showing response to the question: How old are you?




Figure 44: Chart showing response to the question: Which of these best describes your working status?




Figure 45: Pie chart showing response to the question: With which ethnic group do you most identify?




Figure 46: Chart showing response to the question: Which of the following best describes your household makeup?




Figure 47: Pie chart showing response to the question: Including yourself, does anyone in your household have mobility issues?




Figure 48: Pie chart showing response to the question: To which of the following sectors does your business belong?




Figure 49: Chart showing response to the question: Who tends to visit or use your business most?




Figure 50: Chart showing response to the question: How many employees does your business or organisation have, including yourself?




Figure 51: Pie chart showing response to the question: What is your gender?




Figure 52: Chart showing response to the question: Which of these best describes your working status?




Figure 53: Pie chart showing response to the question: With which ethnic group do you most identify?




Figure 54: Pie chart showing response to the question: Do you or anyone you usually visit Crookes and/or Walkley with have mobility issues?




Figure 55: Chart showing response to the question: Which of the following modes of transport do you have personal access to?




Figure 56: Pie chart showing response to the question: How old are you?







Changes to the Active Neighbourhood


We listened carefully to feedback from local people throughout the trial period and made some changes to the Active Neighbourhood as a result.

- As the closure at the junction of Sackville Road and Pickmere Road reduced through-traffic sufficiently, we removed the closure at the junction of Sackville Road and Romsdal Road.
- To provide an alternative route during snowy periods and to retain access to the church and pub, we removed the closures on Slinn Street.
- To allow easier refuse collection, we repositioned the closure on Newent Lane.
- To maintain an access route between Crookes and Walkley we removed the closure at the eastern junction of Matlock Road and Heavygate Road
 To maintain sufficient space for vehicles to manoeuvre, we removed the diagonal closures on Springvale Road at the junctions with Cobden View Road and Western
- Road.
 As the double yellow lines on the corners of Western Road and Cobden View Road were no longer necessary following the removal of the diagonal closures, we restored the double yellow lines to their original lengths.
- To reduce the impact of displaced traffic using Melbourn Road, we removed the one-way restriction on Springvale Road
