Terms and Conditions

1. Promoter

2. Eligibility

2.1 The prize draw is open to any individual who completes the Climate Survey, including residents, workers, visitors, students and City of London Corporation staff.

2.2 Participants must be at least 10 years old.

2.3 Only one entry per person is permitted.

3. How to Enter

3.1 To enter, participants must complete the Climate Survey between 01:00 on 04 May 2026 and 23:59 on 08 July 2026.

3.2 Entry into the prize draw requires submission of contact details via the prize draw entry form.

3.3 Survey responses will remain anonymous and will not be linked to prize draw contact details.

3.4 No purchase is necessary.

4. Opening and Closing Dates

4.1 The prize draw opens at 01:00 on 04 May 2026.

4.2 The prize draw closes at 23:59 on 08 July 2026.

4.3 Entries received after the closing date will not be included in the draw.

5. The Prize

5.1 Ten (10) Town & City Gift Cards UK valued at £50 each are available to be won.

5.2 The Promoter reserves the right to substitute the prize with another of equal or greater value if circumstances beyond its control make it necessary to do so.

5.3 The prize is non-transferable and no cash alternative will be offered.

6. Winner Selection and Notification

6.1 Winners will be selected at random from all eligible entries within 16 days of the closing date.

6.2 Winners will be notified via the contact details provided.

6.3 If a winner does not respond within 7 days, the Promoter reserves the right to select an alternative winner.

7. Data Protection

7.1 Personal data supplied for the prize draw will be used for:

- Administering the prize draw,
- Contacting winners,

7.2 Contact details will be held securely and deleted within one year of the prize draw closing, unless retention is required for administrative or legal purposes.

7.3 Survey responses remain anonymous and are never linked to prize draw contact details.
