
#### NOTICE

The drain trap which is provided by the installer should also be plastic to completely isolate the cooler from the building plumbing system.



A = Recommended water supply location. Shut off valve (not furnished) to accept 3/8" O.D. unplated copper tube connect. Up to 3" (76mm) maximum out from wall. B = Recommended waste outlet location. To accomodate 1-1/4" nominal drain. Drain stub 2" (51mm) out form wall.

C = 1-1/4" Trap (not furnished).
D = Electrical Supply (3) Wire Recessed Box Duplex Outlet.

E = Insure proper ventilation by maintaining 6" (152mm) (min.) clearance from cabinet louvers to wall. F = 7/16" (11mm) Bolt holes for fastening to wall.
