Problem/Motivation

- MoH implement the policy for the shop owner to record all clients that visited their shop, but the shop owner can't record all their clients and it is not a digital copy.
- **CONSEQUENCES:** When there are COVID patient detected with in the community, it take some time to generate a visited locations report. Risk of infected the officers who interview the patients.

Solutions

- This application will provide a way for all locations owner to record or keep a log of the people that visit their place like restaurants, building owner/management, local market, supermarkets, shopping centers, government buildings, schools, homes...
- Benefit:
 - MoH, MoI and relevant authorities can use the data to produce a social network report of the COVID-19 patient base on the places that they visit or base on the how many and who are the people that visited that location.
 - The system allows authority to highlight people that are COVID-19 patients, those who are conducting self quarantine. Which will alert the location owner of their visitor's status if they are safe, quarantine or COVID-19 patient.

Easy to roll out


- Technical Requirements for end users:
 - No phone configuration required
 - No application download/updated required
 - Required the store to print QR code on paper.
 - Client can use Built-in Camera on their phone
 - No battery consumption
- We need to collaboration from the building owner only.
- Now most of the building owner/management ask the client to
 - Clean hand with alcohol
 - Wear mask
 - Next, we just add scan QR code
 - Client just simply use the Built-in Camera on their smartphone

Technology Focused Approach




