VIR CR Deposit might be due in the 2024 but hoping for Jan 2025 Is our cash earning a %, at BoA assuming approx. 5% interest.

# **CR CMP 2024:**

- Advertised about the CR CMP Vintage runoffs, used various social media platforms, Dale and Bill have been attending other CR and DE events to talk up the CR CMP 2024.

- Reg opens Sept 2
- Pit Crew Challenge is back this year
- Want Tyler to get the message out to Social Media ASAP, we also need to promote it on the website with a main page banner, someone who doesn't care for club racing won't click on the club race tab, ask Zone 3 Rep to include in next email blast with a banner/graphics
- Looking to run 2 DE groups, one instructed and one solo, hopes it will get people excited for Club Racing.
- Host hotel is well set up and we have entertainment set up.
- Dale is beginning to assign volunteers but we do not yet have an announcer.

# CR VIR 2025:

- Awaiting confirmation for the dates from VIR, contracts are not negotiated until Jan 2025 but preliminary will happen Sept 2024.
- Sponsor discussions have begun, we already have: Autometrics, Eurosport, Quantum, Kelly Moss, Carl Tallardy, Hardpoint, Porsche of Charlottesville and more to come.
- Entry fee will be \$850/\$250 which is an increase to keep pace with other CRs and venues.
- Dale and Bill have spoken to Phil Grandfield about his volunteers and 90% have responded that they will be at the 2025 CR.
- Planning for a Friday Night Social and Saturday Night Driver Celebration with entertainment.

- Preparing a revised budget for 100 racers and 40 DE participants.
