Focused on family and community

To begin, we ask the question, "What is most important to us and our families?" Once consensus is reached on the project focus, the work begins, cultivation events organized, and personal contacts made.

Tremendous support allowed the WLC to address the priorities of us and our families including:

- **One Heart Cardiology Campaign:** Raised \$400,000 matched \$ for \$ by our hospitals for a diagnostic heart center One Heart Cardiology Suite at the Howard Young Medical Center (HYMC).
- **CT Scanner:** Raised \$230,000 to support the purchase of the SOMATOM® Definition Flash 128-Slice Dual-Source CT scanner, which delivers the best image quality currently available, and is now on duty at HYMC.
- **Early Detection - Here and Now Campaign:** Raised \$350,000 to improve the imaging department at Howard Young Medical Center with a 3D Mammography system matched \$ for \$ by our hospitals. WLC also remodeled the Imaging Department's waiting and changing areas creating a sense of comfort and serenity.
- **Tick-Borne Illness Center:** Raised \$2.1 million to make a Center to diagnose, treat and research tick-borne illness a reality. The Center gives those suffering from a tick-borne illness hope that they can get better.
- **Rising STAR Transition Center:** Raised \$800,000 for the establishment of Rising STAR Transition Center for students ages 18-21 with an individualized Education Program (IEP). The Center focuses on teach life skills and independence.
- **Legacy of Love:** Raised \$160,000 for 560 days of patient care at Seasons of Life Hospice House and to support Medical Technician certification training.
