By accepting the provisions of this Agreement, you acknowledge that you have thoroughly read and agree to all the terms and conditions set out herein. If you do not agree with these General Terms and Conditions, you must not access our website for use or purchase BitleagueCoin Tokens. These General Terms & Conditions (hereinafter referred to as the “Terms”), including any and all Additional Documents, constitute a legally binding agreement between the BitleagueCoin (hereinafter referred to as “Company”, “BitleagueCoin.com”, “BitleagueCoin”, “we”, “us”) You can review our team here: <https://bitleaguecoin.com/team/>. By using the website, and/or purchasing BitleagueCoin Tokens, the respective Participant agrees that they have thoroughly read, understood, and irrevocably accepted these Terms. If any Participant does not agree with these Terms in general or in part, such Participant should withhold from using the Website, BitleagueCoin.com, and/or the purchase of BitleagueCoin Tokens as defined in the Definitions Section herein. Unless otherwise stated, these Terms govern only Participant’s purchase of Tokens from us during the Sale Period. ### **1. DEFINITIONS**

The following definitions and rules of interpretation apply in these Terms:

**Agreement** – These Terms and any other rules, policies or procedures that may be issued by <https://bitleaguecoin.com/> and published from time to time on the Website (including the accompanying documents).

**Affiliate** – Any person or entity that has any relationship with <https://bitleaguecoin.com/>, including, but not limited to partners, employees, agents, and contractors of <https://bitleaguecoin.com/>.

**Applicable Law** – Law applicable under these Terms to any relationship between a Participant and <https://bitleaguecoin.com/>

**Platform** – A digital platform (not a legal entity), designated for gaming and other sports-related services with the use of Ethereum Smart Contracts. Development and launch of <https://bitleaguecoin.com/> is the initial and primary purpose of the BitleagueCoin Token Sale.

**Cryptocurrency** – Digital currency represented by Ethereum (ETH) used by Participants to purchase BitleagueCoin Tokens.

**Intellectual Property Rights** – Any invention, patent, utility model right, copyright and related right, registe-

d design, unregistered design right, trade mark, trade name, internet domain name, design right, design, service mark, database rights, rights in get-up and trade dress, rights in goodwill or to sue for passing off and any other rights of a similar nature or other industrial or Intellectual Property Rights owned or used by <https://bitleaguecoin.com/> in any part of the world whether or not any of the same is registered (or capable of registration), including applications and the right to apply for and be granted, extensions or renewals of and rights to claim priority from, such rights and all equivalent or similar rights or protections which subsist now or will subsist in the future.

**Tokens** – Digital cryptographic Tokens, which are digital software products based on Ethereum blockchain

**BitleagueCoin Token Sale** – An offering of BitleagueCoin Tokens to eligible Participants to purchase BitleagueCoin Tokens during a limited period, according to the respective phases (launches) and price.

**Ethereum Smart Contract** – Digital computer protocol intended to facilitate, verify, and enforce the negotiation and purchase of Tokens by a Token Sale Participant.

**Tokens Sale Participant (“Participant” or “You”)** – Any person, who uses the Website and purchases BitleagueCoin Tokens. The Company reserves its right to set forth at any time upon its discretion, special eligibility, or other requirements to specific Token Sale Participants to participate in a specific phase of BitleagueCoin Tokens Sale.

**Website** – a set of information and Client’s software, combined under one web-address (domain name) located in the information and telecommunication network Internet at <https://bitleaguecoin.com/>.

In the Terms, unless the opposite is clear from the context:

- Unless the context otherwise requires, words in the singular shall include the plural, and in the plural, shall include the singular;
- Unless the context otherwise requires, a reference to one gender shall include a reference to the other genders.
- References to clauses and appendices are to the clauses and appendices of these Terms and references to paragraphs are to paragraphs of the relevant appendix;
- A reference to any party shall include that party’s representatives, successors and permitted assigns.
- All references to a person include firms, companies, government entities, trusts, and partnerships or other or unincorporated body (whether having separate legal personality);
- The term “including” does not exclude anything not listed;

- A reference to a law, statute or statutory provision is a reference to it as amended, extended, or re-enacted from time to time;
- A reference to a law, statute or statutory provision shall include all subordinate legislation made from time to time under that statute or statutory provision.
- A reference to writing or written includes fax and e-mail.
- Any obligation on a party not to do something includes an obligation not to allow that thing to be done by the other person.
- Any words following the terms “including”, “include”, “in particular”, “for example” or any similar expression shall be construed as illustrative and shall not limit the sense of the words, description, definition, phrase, or term preceding or following those terms

## 2. ESSENTIAL CONDITIONS AND EXHAUSTIVE NATURE OF THE AGREEMENT

#### 4. GENERAL PROVISIONS

You also represent and warrant that You are not a citizen or resident of a geographic area in which Applicable Law prohibits access to or use of the Cryptocurrency or Tokens, decree, regulation, treaty, or administrative act. We shall reserve the right to refuse to sell BitleagueCoin Tokens to anyone who does not meet the criteria set forth above.

4.2 By using this Website each Participant covenants, represents, and warrants that (under the Applicable Law and law of the country of Participant’s residence):

11.3 BitleagueCoin Tokens carry no rights, express or implied, other than those, set out herein, subject to BitleagueCoin successful completion and deployment of the Platform. BitleagueCoin Tokens holders shall not have any influence on the development or governance of <https://bitleaguecoin.com/>. BitleagueCoin Tokens do not represent or constitute any ownership right or stake, share or security or equivalent rights or any right to receive future revenue shares, or any other form of participation in or relating to <https://bitleaguecoin.com/>.

11.4 BitleagueCoin Tokens are designed to be exchangeable on cryptographic Tokens exchanges. <https://bitleaguecoin.com/> gives no warranties that BitleagueCoin Tokens will be exchangeable on more prominent stock exchanges but undertakes on best effort bases to do everything that is possible and within the powers of <https://bitleaguecoin.com/> to enable the exchange of BitleagueCoin Tokens on as many exchanges as possible.

11.8 <https://bitleaguecoin.com/> reserves the right to an emergency stop functionality to stop the distribution process. Use of this functionality shall remain in the discretion of <https://bitleaguecoin.com/> and shall only be used in limited situations, such as:

1. serious security issue detected;
2. serious network performance issue, depriving all users of equal treatment;
3. any physical attack on BitleagueCoin Tokens, the Platform, Website or Ethereum network.

11.9 BitleagueCoin Token Sale and distribution will be offered only through the Website. No third-party website or another provider can distribute and sell BitleagueCoin Tokens. No third-party website or a different provider is allowed and has not been in any way supported, engaged, authorized, or endorsed by <https://bitleaguecoin.com/> and have no relationship in any way with <https://bitleaguecoin.com/>. The only official and authorized website and BitleagueCoin Tokens distribution provider is the Website available at <https://https://bitleaguecoin.com/>. The Participant must ensure that the URL of your web browser indicates that it is using a hypertext transport protocol secure connection (“https”) and that the domain name is correct.

11.10 BitleagueCoin Tokens is not a consumer product, and its holders accept explicitly and agree to it that they are not covered by the consumer protection regulation of any jurisdiction.

11.11 BitleagueCoin Tokens can be used for sport, gaming and betting and any other products and services provided on the BitleagueCoin Platform.

## **12. RISKS**

12.1 BitleagueCoin Tokens are issued on the blockchain Ethereum platform. Blockchain, Ethereum, Ether and other associated and related technologies are new, untested and outside of <https://bitleaguecoin.com/>'s exclusive control and adverse changes in market forces or the technology, broadly construed, may pre-

vent or compromise, negatively influence or call into question Bitleaguecoinico.io's performance indicators and results under this Agreement. Participant agrees that no other party (including, without limitation term "any party") may be held liable for any loss arising out of, or in any way connected with Participant's participation in BitleagueCoin Token Sale or receiving and holding Tokens or such risk. In addition to the above, the Participant also acknowledges that before receiving Tokens they have been warned of the following risks, associated with the Website, <https://bitleaguecoin.com/> Tokens, the Platform and other relevant technologies mentioned herein:

12.2 Legal risks regarding securities regulations. There is a risk that in some jurisdictions BitleagueCoin Tokens might be a security, or that it might be a security in the future. <https://bitleaguecoin.com/> does not give warranties or guarantees that BitleagueCoin Tokens are not a security in all jurisdictions. Each holder of BitleagueCoin Tokens shall bear its own legal or financial consequences of BitleagueCoin Tokens being considered a security in their respective jurisdiction. 12.4. Risk of unfavorable regulatory action in one or more jurisdictions. Blockchain technologies



have been the subject of scrutiny by various regulatory bodies around the world. The functioning of the Ethereum network and associated blockchain networks and BitleagueCoin could be impacted by one or more regulatory inquiries or actions, including but not limited to restrictions on the use or possession of digital Tokens like BitleagueCoin, which could impede or limit their existence, slow or limit their functionality or BitleagueCoin buyout in the future, permissibility of their use and possession, and their value.

12.5 Risk of theft and hacking. Hackers or other groups or organizations may attempt to interfere with Your Third-party Wallet, the Website, BitleagueCoin Tokens and Digital Assets in any number of ways, including without limitation service (DDoS) attacks, Sybil attacks, spoofing, smurfing, malware attacks, or consensus-based attacks.
