With its increased inner bore, called Optiflow, Tigris K5 now is best in class in flow performance. And for a reliable press connection, the new Tigris K5 features Multijaw, which means that the fittings can now also be pressed with the most common pressing profiles like U and Up, TH, H and B.

This LCA was evaluated according to EN15804+A2. It was concluded that the LCA complies with this standard.
