#### **PRODUCT DESCRIPTION**

110C/IS/250 Ventilation Pipe: Insulated sewer ventilation pipe without a cowl. Should be installed in a sheet metal cone with a Ø 170 mm opening, made by a tinsmith.

125C/400 FLOW Ventilation Pipe: Installation into a cone made by a sheet metal worker, with an upper diameter of  $\emptyset$  170 mm.

110P/300 FLOW Ventilation Pipe + Cowl: Uninsulated ventilation pipe with FLOW cowl. VILPE pass-throughs suitable for a range of roofing types and material are available separately.

110P/500 Ventilation Pipe: Uninsulated ventilation pipe. A pass-through according to the roofing material is required separately. A VILPE Cowl-110 is required for ventilation of attic space and roof structures.

160P/500 Ventilation Pipe: Uninsulated ventilation pipe without a cowl. VILPE pass-throughs suitable for a range of roofing types and material are available separately.

110P/IS/350 Ventilation Pipe: Insulated sewer ventilation pipe without a cowl. Should be installed in a sheet metal cone with a Ø 170 mm opening, made by a tinsmith.

110P/IS/350 Ventilation Pipe + Cowl: Insulated ventilation pipe with FLOW cowl. VILPE pass-throughs suitable for a range of roofing types and material are available separately.

110P/IS/500 Ventilation Pipe: Insulated sewer ventilation pipe without a cowl. VILPE pass-throughs suitable for a range of roofing types and material are available separately.

110P/IS/900 Ventilation Pipe: Insulated sewer ventilation pipe. Additionally, a VILPE pass-through, chosen according to the roofing material, and a flexible pipe, if needed, are required. When used as a Radon ventilator, a VILPE FLOW cap 160 is also required.

Freeze 110/475: Insulation cover for old  $\emptyset$  110 sewer ventilation pipes. Renews pipes' appearance and colour.

Freeze Cover 110/865: Insulation cover for old  $\emptyset$  110 sewer ventilation pipes. Renews pipes' appearance and colour. Ensure sufficient fastening in windy areas.

### **MANUFACTURING AND PACKAGING (A1-A3)**

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

# VILPE

Ventilation pipes of VILPE Oy are manufactured at the Mustasaari site in Finland. The production process consists of raw material delivery, injection molding, quality inspection, and packaging. During injection molding, the raw material is plasticized, injected into the mold, cooled, and removed from the mold. Plastic inner pipes are injection molded on-site. Some assembly is automated. Production requires electricity, heat, and water. Slightly less than 10% of the electricity comes from the production facility's own solar power plant, and until the end of 2023, the rest is from general electricity, after which it will be nuclear electricity. The waste heat from the machines is directed to a heat recovery center and used for building heating. The cooling water is in a closed loop. The material requirement and generated waste vary depending on the size of the product. Production waste is recycled in the process for other products.

### **TRANSPORT AND INSTALLATION (A4-A5)**

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions.

The average distribution distance is calculated as a weighted average of the significant sales volumes. Products are transported in full pallets. During installation, the disposal of packaging material is included in the estimate. Ventilation pipes are packed in cardboard boxes and some also in plastic bags. The amount of packaging material varies slightly depending on the type and size of the ventilation pipe. After installation, the packaging material is transported by truck to a recycling facility. The average distance to a recycling facility in Finland has been used. Scenario estimates have employed average recycling methods and practices. There is no material waste during installation. The energy consumption during installation, mainly consisting of the use of a drill, has been excluded from the calculations as it is assumed to be insignificant per examined product unit.





### **PRODUCT USE AND MAINTENANCE (B1-B7)**

This EPD does not cover the use phase. Air, soil, and water impacts during the use phase have not been studied.

### **PRODUCT END OF LIFE (C1-C4, D)**

The end-of-life stage consists of the following modules:

- C1: Deconstruction of the product
- C2: Transportation of the discarded product
- C3: Waste processing
- C4: Disposal

The end-of-life scenario represents the most likely option in Finland. The average distance to waste treatment facilities in Finland has been used for waste transportation distance. The end-of-life scenario is based on the recycling practices available in Finland. After disposal, it is assumed that the polypropylene of the exhaust ventilation will be incinerated and metal parts are recycled. Due to the energy usage possibilities of the product and packaging, recycled raw material leads to the avoidance of virgin material while energy recovery at the incineration plant displaces electricity and heat production.

### LIFE-CYCLE ASSESSMENT

### **CUT-OFF CRITERIA**

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.

### ALLOCATION, ESTIMATES AND ASSUMPTIONS

Allocation is required if some material, energy, and waste data cannot be measured separately for the product under investigation. All allocations are done as per the reference standards and the applied PCR. In this study, allocation has been done in the following ways:

The average consists of 110C/IS/250 Ventilation Pipe, 125C/400 FLOW Ventilation Pipe, 110P/300 FLOW Ventilation Pipe + Cowl, 110P/500 Ventilation Pipe, 160P/500 Ventilation Pipe, 110P/IS/350 Ventilation Pipe, 110P/IS/350 Ventilation Pipe + Cowl, 110P/IS/500 Ventilation Pipe, 110P/IS/900 Ventilation Pipe, Freeze 110/475, Freeze Cover 110/865. For the calculation six different ventilation pipes were selected, and the middle size ventilation pipe was selected to serve as a representative product. All products are comparable in terms of their primary material composition. The differences between them arise primarily from variations in weight and size, as well as the amount of packaging and transportation material required per kilogram of product. All products were manufactured at the same location in Mustasaari, and their intended uses are similar and comparable. In the averaging method, raw materials, packaging, and transportation materials, including transportation distances, were allocated on a per-kilogram basis. Additionally, the energy consumption during manufacturing was allocated per kilogram of product. The transportable mass of the product, end-of-life considerations, and any resulting benefits or drawbacks are specific to each product. The resulting calculations were compared across the products, ensuring that the range of variation remains sufficiently narrow.





### LCA SOFTWARE AND BIBLIOGRAPHY

This EPD has been created using One Click LCA EPD Generator. The LCA and EPD have been prepared according to the reference standards and ISO 14040/14044. The EPD Generator uses Ecoinvent v3.8, Plastics Europe, Federal LCA Commons and One Click LCA databases as sources of environmental data.
