## What is the Foundation?

The Arcadia People for Christ (APC) Foundation is a California nonprofit corporation established by Arcadia Community Church (formerly Arcadia Presbyterian Church) more than 35 years ago to support the work of the Church.

Although now independent, its purposes remain the same. It is a tax-exempt 501(c)(3) organization under the Internal Revenue Code.

## Statement of Purpose

The purpose of the APC Foundation is to support the work of Christ through

- (i) the ministries of the Church,
- (ii) missions here and abroad,
- (iii) campus maintenance, and
- (iv) training future leaders called to ministry.

This is accomplished through careful stewardship of gifts from individuals and families that are invested conservatively to provide long-range income to support the purposes of the Foundation.



## How can I help achieve these goals?

The Foundation relies on the gifts of faithful friends who want to provide the necessary resources to proclaim the gospel in the future.

These contributions are not to take the place of tithes and offerings we give weekly out of income to sustain the ongoing Church programs. Instead, these are special gifts such as a one-time contribution of cash or property, and bequests through wills, trusts, life insurance or Individual Retirement Accounts (IRAs). Some of these charitable options can help reduce income and/or estate taxes.

## Can I designate my gift for a specific program?

Yes. Although undesignated gifts are welcome, gifts to the Foundation may be designated for a specific area of ministry need. The Foundation has established four funds that may simplify such designations:

**1. Local Ministries.** This fund will support ministries of the Church including youth camp scholarships, pastor housing, and local missions.

**2. Leadership Development.** This fund is dedicated to defray the costs of seminary education including tuition, books and housing for those called to the ministry or mission field.

**3. World Impact.** This fund is applied to mission capital projects, short or long term mission projects and conference training.

**4. Campus.** This fund is applied toward updating the Church property as necessary to assure it continues to serve the needs of the various Church ministries.
