PROSECUTE GENOCIDE

CAMPAIGN BRIEF

BACKGROUND

October 7th marks **one year since the Israeli government initiated its genocidal campaign** against the people of Gaza and occupied Palestine, leading to widespread destruction, immense suffering, and severe disruptions to the delivery of humanitarian aid. **These actions have crippled Gaza's ability to recover and rebuild.**

Israel's actions in the occupied Palestinian territories have been **condemned by human rights organizations and the international community as violations of international law**. These include illegal settlements, forced displacement, indiscriminate bombings of civilian areas, and the systemic oppression of Palestinians, **constituting ethnic cleansing and genocide**.



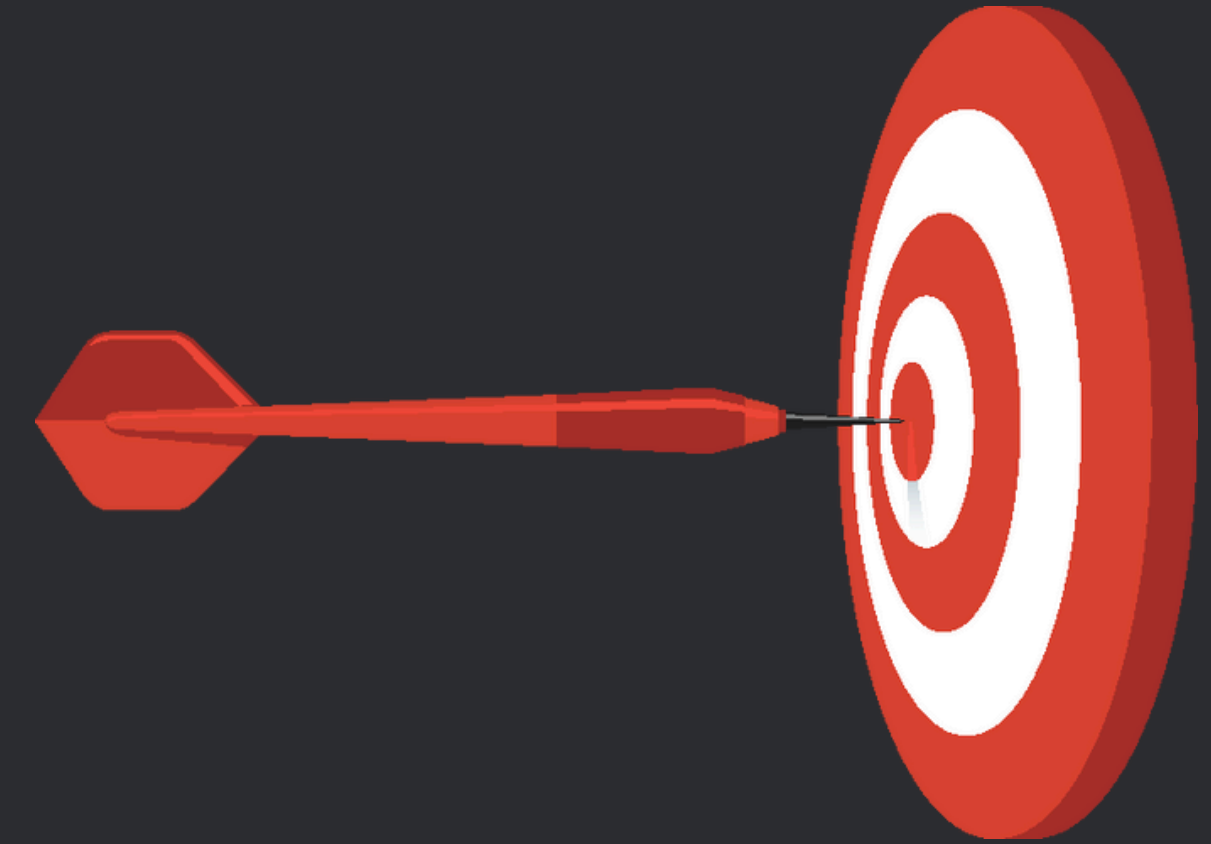
The UK has a legal and moral obligation to prosecute its nationals who travel abroad to participate in, support, or profit from such atrocities. As with other war crimes, the principle of universal jurisdiction **allows states to prosecute individuals for heinous crimes committed beyond their borders**. By failing to investigate and prosecute those involved, the **UK becomes complicit in these violations of human rights**.

To mark this day, **Human Aid & Advocacy is launching the 'Prosecute Genocide' campaign**, aimed at pressuring UK lawmakers to hold accountable those responsible for facilitating, participating in, or contributing to war crimes and violations of international law that have not only harmed Palestinians but also obstructed vital aid efforts.

AIMS & OBJECTIVES

The **#ProsecuteGenocide** campaign seeks to lobby the British government and the Metropolitan Police to open criminal investigations into British nationals who have travelled to Israel and contributed to its genocide and war crimes against Palestinians.

Given that Israel has been found guilty of multiple violations of international law, including war crimes, British citizens who have supported, facilitated, or participated in these actions should be held accountable under UK law.



Our goal is to ensure justice for the Palestinian victims of these atrocities and to send a strong message that participation in genocide and war crimes will not go unpunished, regardless of where they occur.

CAMPAIGN JOURNEY

Sept–October 7th

PHASE 1

- 1. Public Awareness:** Through social media, press campaigns, and public demonstrations, #ProsecuteGenocide will raise **awareness** of British nationals' involvement in war crimes abroad.
- 2. Lobbying:** We will pressure the Metropolitan Police to uphold their duty to investigate war crimes and **prosecute** such offenders.
- 3. Collaborating with Advocacy Groups:** By aligning with Palestinian advocacy organizations and international human rights groups, we aim to bring the voices of those affected by Israeli war crimes to the forefront of the campaign, ensuring that their calls for justice are amplified. **Collectively we will lobby for those who participated in the genocide to be prosecuted.**



October to December 2024

- 1. Analysis:** We will use testimonials, expert analyses, and reports from human rights organizations to expose the extent of British citizen's involvement in the Gaza genocide.
- 2. Legal Support:** The campaign will collaborate with legal experts to file complaints and prepare legal cases against those suspected of war crimes. We will work with international legal organizations to provide evidence and build a robust case for prosecution. Look into British Palestinians/dual citizens who have had family members killed by IOF. Look into dual national aid workers who have been killed.
- 3. Political Lobbying:** We will work with MPs, legal experts, and activists to put pressure on Parliament to take action and ensure the Metropolitan Police are held accountable for their duty to investigate these crimes.



OUR CAMPAIGN DEMANDS



1. Open Investigations

The British government and Metropolitan Police **must open investigations into any British nationals who have travelled to Israel to support its illegal activities, including those involved in illegal settlements, financial support, or military actions contributing to war crimes.**

2. Prosecute War Crimes

British nationals found to have directly or indirectly contributed to ethnic cleansing, genocide, or other war crimes in Israel and Palestine **must be prosecuted under UK law, in line with international legal obligations.**

3. Justice for Palestine

The campaign seeks **justice for the Palestinian people, who have suffered decades of occupation, systemic violence, and human rights abuses by the Zionist entity.** Those who contributed to these atrocities should not evade accountability.

4. Enforce International Law

The UK government must show its commitment to upholding international law by **ensuring that no British citizen is involved in war crimes, regardless of where they occur.**

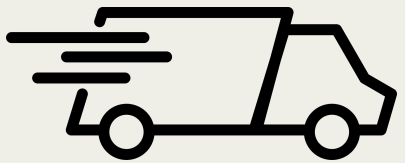
Prosecute Israeli War-Crimes!
