Every effort will be made to reschedule with priority given to any qualifying classes being offered. No refunds for cancellations due to hazardous weather, Acts of God, accidents or emergencies (within reason- if we get ample warning for weather and chose to cancel a show we may offer to extend your entry payments to the next show or refund).

## Rider Attire: USEF rules and guidelines will be used for attire and equipment.

- 1) Required Attire: Suitable western hat. Protective headgear may be worn without penalty (See GR801) and is STRONGLY recommended.
- 2) Long-sleeved shirt with any type of collar: short sleeves may be worn at the judge's discretion
- 3) Trousers, pants, a one-piece long sleeved equitation suit provided it includes a collar.
- 4) Boots with distinguishable heel. •
- 5) Optional Attire: Necktie, kerchief, bolo tie or pin. A vest, jacket, coat and/or sweater. Spurs. Western style, with or without blunt tines, English dressage style, roller ball, and blunt bumper spurs are permitted. Rowels must be vertical. Spurs with sharp tines are not permitted. Chaps, shotgun chaps, chinks, armitas, or split riding skirt. Protective headgear is acceptable; not required to be of Western style.

**Number of Tests per Horse:** A horse may be ridden up to a MAXIMUM 4 times per day per show (regardless of the number of riders).

### **Arenas:**

**Show arena**: Introductory and basic classes will be in a small ring 20x40. All other classes will be in a 20x60.

**Warm-Up Arenas**: Warm up ring set to the outside from the 2 show rings. No warming up within the show rings on Saturday or Sunday! Lunge ring also provided. No lunging in the warm up areas!

**Show Ribbons:** First through sixth places. High Point and Reserve High Point prizes will be given each day for Open, AA, and JR/YR.

**Ride Times:** Will be posted on <u>www.ringradar.com</u>, and emailed WEDNESDAY before the show, at the latest.

**FCHC Season-End Awards:** Awarded by level to rider/horse combinations that ride at the same level in at least THREE of the 2025 shows.

# **Special Scheduling Requests:**

- Some riders have special scheduling requests due to trailering arrangements, trainers that are riding and coaching, riders with two horses, etc. Although not guaranteed, every attempt will be made to honor these requests, as follows:
  - o If a class can be scheduled at a time frame requested by the rider, this will be done.
  - o If the class cannot be scheduled in this time frame, every attempt will be made to schedule special request rides BEFORE the balance of the class; this is necessary so other riders do not have to wait for the class to finish.
- Please note that special scheduling requests involving a wide variety of tests can be very difficult to honor, but we will try!
- Also please note that scheduling occurs after the closing date; therefore, a ride that is scratched due to a special request that cannot be honored will be considered a scratched ride and the ride fee must be paid.

### **Stabling:**

Permanent 10xl0 stalls with secured doors, Friday 12 PM through Sunday at 7 PM. Additional nights are \$25/night. Two bags of shavings included for horse stalls.

and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

#### WARNING:

Under Florida law, an equine activity sponsor or equine professional is not liable for an injury to, or the death of, a participant in equine activities resulting from the inherent risks of equine activities.

C. ASSUMPTION OF RISK: I understand that the aforementioned Risks may be caused in whole or in part or result directly or indirectly from the negligence of my own actions or inactions, the actions or inactions of others participating in the USEF Events, or the negligent acts or omissions of the Released Parties defined below, and I hereby voluntarily and knowingly assume all such Risks and responsibility for any damages, liabilities, losses, or expenses that I incur as a result of my participation in any USEF Events. I also agree to be responsible for any injury or damage caused by me, my horse, my employees or contractors under my direction and control at any USEF Event.

D. WAIVER AND RELEASE OF LIABILITY, HOLD HARMLESS AND INDEMNITY: In conjunction with my participation in any USEF Event, I hereby release, waive and covenant not to sue, and further agree to indemnify, defend and hold harmless the following parties: USEF, USEF Recognized Affiliate Associations, the United States Olympic & Paralympic Committee (USOPC), USEF clubs, members, Event participants (including athletes/riders, coaches, trainers, judges/officials, and other personnel), the Event owner, licensee, and competition managers; the promoters, sponsors, or advertisers of any USEF Event; any charity or other beneficiary which may benefit from the USEF Event; the owners, managers, or lessors of any facilities or premises where a USEF Event may be held; and all directors, officers, employees, agents, contractors, and volunteers of any of the aforementioned parties (Individually and Collectively, the "Released Parties" or "Event Organizers"), with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss, or expense (including court costs and reasonable attorney fees) of any kind or nature ("Liability") which may arise out of, result from, or relate in any way to my participation in the USEF Events, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties.

# **Membership Statement:**

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes

## **Safe Sport Reminder:**

Reminder: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. ### **Motorized Vehicle Statement:**

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.
