## Travel Document Requirements



Before you set off, make sure your passport is up-to-date, travel insurance is in place, and visa requirements are all checked off. These key steps are your ticket to a smooth, hassle-free journey, so you can focus on what really matters – making memories that will last a lifetime.

### **Passports**

Assuming all passengers on the booking are UK citizens holding British passports, your passport must be valid for at least six months after your return date. Failure to meet this requirement may result in a refusal of boarding.

If any passengers in your party do not hold a British passport, they will need to check with the relevant embassy to confirm their eligibility to travel.

Please also ensure that the names provided at the time of booking exactly match those on your passports. This will help avoid any late amendment fees. If you need to update your passport information, you can do so through your travel agent.

#### Visas

All passengers are responsible for obtaining the necessary visa(s) for their holiday prior to travel.

Together with our preferred visa provider, CIBT, we're pleased to offer a simple online solution to all your visa requirements. Please note: your visa requirements may differ if you do not hold a British passport. In this case, we recommend contacting the relevant embassy or consulate for guidance.

Alternatively, you can contact our recommended visa service, CIBT, on **0844 800 4650**. Be sure to mention if you're travelling by sea, as visa requirements for cruises may differ from those for air travel.

#### Important:

Fines may be imposed if you travel without the correct documentation. It is your responsibility to ensure you have the required visas prior to departure. Failure to do so may result in denied boarding or repatriation in line with government regulations. Be sure to review your itinerary and obtain the visas necessary for the specific countries you'll be visiting. If you're embarking or disembarking a cruise, or staying on board, please consult your cruise line's website for further details.

### Visa Application Timescales

Visa timescales may be longer during periods such as Christmas and/ or when embassies are closed or busy. In addition, your own personal circumstances may affect the timescales quoted. We recommend that you obtain your visa as early as possible.

#### Important Information:


- When applying for your visa, ensure that all guests' full names exactly match those on their passports. Any discrepancies may result in being refused boarding on your flight or cruise
- Passport and visa requirements can change depending on the destination. We regret that we cannot accept liability if you are refused boarding, denied entry, or incur any costs due to incorrect passport details or missing visas
- It is your responsibility to ensure you have all necessary travel and health documents before departure, including covering any costs associated with obtaining them. Some Port Authorities may require photo identification when

- leaving the ship during the cruise. We strongly recommend taking photocopies of your passport's information page, keeping them separate from your passport, and carrying a copy each time you depart the ship. This will provide an official form of ID in case of loss or theft of your passport while onshore
- The information provided is accurate at the time of publishing but is subject to change. British passport information applies to British citizens; holders of passports from other countries must consult their relevant authority. There is often a requirement for a minimum passport validity and several clear pages to gain entry, which may be up to a 6-month validity requirement. We recommend confirming this with the appropriate authority.

#### Travel Insurance

Do I need travel insurance?

Yes, we strongly advise obtaining adequate travel insurance from the day the booking is made. Imagine Cruising will not accept any ability for any passengers who fail to obtain adequate travel insurance.

### Medical, Dietary or Mobility Requirements

To help us assist you, please inform your travel agent of any medical conditions, special needs, medical equipment, or dietary requirements you may have. This includes the weight and dimensions of any equipment, such as walking aids and wheelchairs, as these will need prior approval from the relevant travel provider before departure.

We are unable to provide specific health requirements for travel destinations. Please check the Government website for updates or contact your GP.

#### Vaccination Requirements

Rules and regulations are constantly evolving at the destinations we visit. To make your travel as smooth as possible, we've put together a checklist of things to do and verify before departure:

- Travel Insurance Ensure that your policy includes Covid-19 coverage.
