

Photo Competition – Terms & Conditions

1. Eligibility

- 1.1 The competition is open to individuals aged 18 and over.

- 1.3 By submitting an entry, participants confirm that they meet all eligibility requirements.

2. How to Enter

- 2.1 To enter, participants must submit an original photograph according to the instructions provided by Imagine Cruising.

- 5.1 Winners will be chosen by the Organiser or an appointed judging panel based on criteria determined by Imagine Cruising.
