Proxy Authorization for a Third Party

Shareholders who do not wish to personally participate in the Shareholders' Meeting may have their voting right exercised by proxies such as an intermediary, a shareholder association, other third parties, or a voting rights representative appointed by the Company. First, though, they will have to report their proxy in a timely fashion in accordance with the provisions described in the notice convening the Shareholders' Meeting (see "Attendance at the Shareholders' Meeting and Exercise of Voting Rights").

Text form is generally sufficient for granting, revoking, and presenting proof of proxy authorization vis-à-vis the Company (Section 126b German Civil Code [BGB]).

If the proxy is not granted to an intermediary, shareholder association, voting rights representative, or any other person or institution equivalent to them pursuant to Sections 135 (8) and (10), 125 (5) of the German Stock Corporation Law (AktG), the proxy may be granted in text form (Section 126b German Civil Code [BGB]) to either the proxy agent or the Company. The same procedure can be followed for revoking the proxy.

If the shareholder authorizes more than one person, the Company may refuse one or more of them.
