



Bequests, Wills and Living Trusts

How it Works

In addition to providing for your loved ones, your will or living trust can be one of the most effective ways to make a generous gift to the Detroit Symphony Orchestra. Creating a bequest for the DSO is as simple as stating your intentions when you create your estate plan or will. If you have an existing will or living trust, your attorney can prepare a codicil, or amendment, for you to sign which modifies, explains, or changes your intentions. Bequests in your will or living trust allow you to retain your assets during your lifetime.

Types of Bequests

If you choose to include the Detroit Symphony Orchestra in your will or living trust, there are several types of bequests that allow you to designate how your estate will be distributed.

- **Specific Bequest:** You describe exactly what you want to leave to the Orchestra. You can specify a particular dollar amount, portion (percentage) of your estate, or a particular asset.
- **Residuary Bequest:** You can designate that the Detroit Symphony Orchestra receives all or a portion (percentage) of the remainder of your estate once all specific bequests, debts, expenses, and taxes have been paid.
- **Contingent Bequest:** The contingent bequest is fulfilled if certain conditions are met. For instance, if your primary beneficiary does not survive you, you can indicate a gift to the Orchestra through a contingent designation.

How to Include the Detroit Symphony Orchestra

The following language is an example for how you might word an outright bequest to the Detroit Symphony Orchestra:

"I give, devise and bequeath to the Detroit Symphony Orchestra, which has a federal tax identification number of 38-1385132 and a current address of 3711 Woodward Avenue, Detroit, Michigan 48201, the sum of _____ (state amount or percentage; or describe the asset) to be used for unrestricted purposes (or general endowment purposes)."

Benefits

Bequests to the Detroit Symphony Orchestra help reduce the taxes paid by your estate. There is no limit on the amount you can leave to the Orchestra or to other charitable organizations through your will or living trust.
