Bylaws Rewrite

Bylaws

Of

Prairie Bowmen Inc.

ARTICLE I NAME

The name of this organization shall be Prairie Bowmen, Inc.

ARTICLE II PURPOSE

The purpose of this organization shall be to foster, expand and perpetuate all forms of archery. To encourage the use of the bow and arrow in all aspects of the sport, including hunting and target archery. To encourage Bowhunter Education, and archery lessons toward improving skill and form for all ages. To cooperate with conservation organizations in the conservation and preservation of game and habitat. To promote and perpetuate the taking of game with the bow and arrow, in accordance with game laws and regulations of the state.

ARTICLE III MEMBERSHIP

- All memberships require approval of the Board of Directors, and payment of annual dues. All applicants should demonstrate good moral character and sportsmanship. Article III sections 2-7 describe membership categories.
- Adult single membership shall be granted to anyone who has attained his/her eighteenth (18) birthday.
- Family membership shall consist of the application member, spouse and immediate family under eighteen (18) years of age.
- College membership shall be granted to anyone that is a full time student while attending College, Junior College, or a community College. The Board of Directors may set reduced dues for college memberships. They must provide a photo ID with application
- Junior membership shall be granted to anyone who is under eighteen (18) years of age provided such applications are sponsored by an adult member who accompanies the junior member in the use of the Club facilities.
- Honorary membership may be granted at the discretion of the Board of Directors.
- All individuals that have been members in good standing for twenty (20) consecutive years shall be entitled to Lifetime Membership status. Once lifetime status has been reached annual dues may be waived. Lifetime members will still be responsible to pay special assessments should any occur.
- The Board of Directors may suspend or expel any member for conduct detrimental to the interests of the organization.
- Voting privileges shall be granted to each adult member current in their dues. One (1) vote for single membership and two (2) votes for family

memberships.

- Membership dues are due January 1 of each year if member joined before January 1, 2004. After January 1, 2004, dues are due on your anniversary date. Members shall be considered delinquent when dues are thirty (30) days in arrears. Members in arrears on their dues will be sent a reminder notice; if dues are not paid within sixty (60) days of original due date, all club privileges and activities will be automatically revoked at that time.
- Members delinquent in dues and no longer in good standing may be reinstated to active membership upon approval by the Board of Directors.
- A leave of absence may be approved upon written request to the Board of Directors. Military and unusual leaves of absence may be considered by the Board of Directors following written request for such leave.

ARTICLE IV BOARD OF DIRECTORS

- The Board of Directors shall consist of a President, Target Coordinator or 1st Vice President, Range Master or 2nd Vice President, Bowhunting Coordinator or 3rd Vice President, Secretary, Treasurer, Newsletter Coordinator, Youth Education Coordinator, and Web Site Coordinator. The retiring President may serve as an ad-hoc member to the Board of Directors for a period of one year.
- The Board of Directors shall control and manage the activities, policies and property of the organization.
- At any regular meeting of the Board of Directors, five (5) members of the Board shall constitute a Quorum.
- All vacancies of the Board, shall be filled from the membership, by an appointment from the Board of Directors.
- The President or any three (3) members of the Board of Directors can call a special meeting of the Board of Directors.
- The Board of Directors shall hold regular meetings at a time and place as directed by the President.
- The Board of Directors by simple majority vote,

which shall include the President's vote, may replace any board member, if in the opinion of the Board, that Board member is not living up to the responsibilities of that office.

ARTICLE V

DUTIES OF DIRECTORS

- The President: Shall call and preside at all meetings, appoint all committees, direct and approve communications to the general membership, settle disputes, attend or appoint a representative to attend statewide meetings, vote in the case of a deadlock on board issues, and maintain decorum at all board meetings according to Roberts Rules of Order. Shall in general perform all other duties incidental to the office.
- The Target Coordinator/ 1st Vice President: Shall coordinate target tournaments and both winter and summer target leagues. Shall prepare information to advertise target tournaments and leagues. Provide target tournament results to Web site Coordinator within 2 days of tournament completion. Shall present a budget for all expected target expenses. Shall coordinate with Rangemaster for target repairs and maintenance. Shall collect monies from tournaments and leagues and either deposit into the bank or present to the treasurer within 2 working days of collection. Shall provide the Board of Directors a detailed report of money received and shooter numbers at all target events. Shall co-coordinate the Club Championship events and club jamboree with the Bowhunting Coordinator. Shall in general perform any other duties incidental to this office. 1st Vice President shall perform the duties of the President if this person is unable to act.
- The Rangemaster or 2nd Vice President: Duties shall include coordinating improvements and the maintenance of the Prairie Bowmen property and both indoor and outdoor ranges. Shall in general perform all other duties incidental to this office.
- The Bowhunting Coordinator/ 3rd Vice President: Shall coordinate all 3-D tournaments. Shall hold and coordinate both indoor and outdoor Bowhunter leagues. Maintain all 3-D targets, repair and replace when needed. Provide the

Board of Directors with an annual budget request for expenditures on said targets. Shall collect all monies from 3-D tournaments and leagues and either deposit in bank or deliver to Treasurer within 2 working days after the event. Shall provide the board of Directors a detailed breakdown of money received and shooter numbers at all Bowhunter events. Shall cocoordinate the Club Championship and Jamboree with the Target Coordinator. Shall in general perform all other duties incidental to this office.

- The Secretary: Shall keep all minutes and records of the organization. Shall serve all notices of club meetings via the newsletter, social media and website. Shall coordinate with club president on all official club correspondence. Shall maintain membership records. Shall maintain an up to date club mailing and e-mailing list. Shall present written reports when requested by the Board. Shall provide written and verbal minutes of previous meetings at each board meeting. Shall in general perform all other duties incidental to this office.
- The Treasurer: Shall receive all monies of the organization and/or provide Target Coordinator and Bowhunting Coordinator with deposit tickets for direct deposit. Shall maintain checking and savings accounts as appropriate. Shall write all checks and pay all bills of the organization. Shall maintain paid-up insurance, leases and mortgages for the club. Shall keep accurate records of the receipts and disbursements to include a complete breakdown by categories such as, 3-D, Target, Youth, Range maintenance, etc., and present written reports at all board meetings and any annual meetings of the club. Shall in general perform all other duties incidental to this office.
- The Youth Education Coordinator: Shall coordinate all the youth activities of the club. Shall provide a budget request and an action plan of all youth activities to the Board of Directors. When/if a Kids Camp is held, shall coordinate all activities associated with the camp, including advertising and promotion and shall provide the Board with a complete accountability of expenses and income for the camp. Shall in general perform all other duties incidental to this

office.

- The Website Coordinator: Shall maintain the website. The website shall be kept up to date with the clubs newsletter, calendar of events, meeting notifications, and tournament results. Shall in general perform all other duties incidental to this office.
- The newsletter Coordinator: Shall publish the Club's newsletter quarterly and within 14 days of the Board meeting of that quarter. When directed by the board of directors, additional newsletters may be published. Shall coordinate with the Secretary to secure up-todate mailing and e-mailing lists. Shall coordinate with the Treasurer in advance for funds to purchase all supplies including postage. Shall coordinate with all board members for newsletter articles and fliers for the newsletter. Shall send club e-mails and update social media when requested by the Board. Shall in general perform all other duties incidental to this office.
- The board may, by unanimous vote, combine board positions, provided the total number of board members remains an odd number. In no case would the board be reduced to less than 5 members. In the event that positions are combined, a bylaw change would be required for those changes to become permanent.
- All board members (or their proxy) are expected to attend all board meetings. If a board member finds that work or other conflicts continue to make attendance at regular board meetings difficult, that board member should step down from their position and allow the Board to fill the position with another club member. Board members shall promote all club functions and try to attend all club functions when possible.

ARTICLE VI ELECTION AND TERMS OF OFFICE

The election for each office will be for a two (2) year term. The following officers will be elected on the even years: President, Secretary, Bowhunting Coordinator, Youth Education Coordinator, and Newsletter Coordinator. The following officers will be elected on

The President shall appoint a Nominating Committee for the purpose of presenting nominations at the October board meeting. Nominations from the floor will be accepted at the October board meeting as well. The secretary shall publish a ballot, which shall include blanks for write-in candidates, for publication in the October newsletter. Ballots may be mailed to the club secretary or appointed representative or may be delivered in person at the November annual Pot-Luck Dinner and club meeting. The nominating committee will be responsible for counting and authenticating the ballots. The newly elected officers will be announced at the November Pot-Luck and they will attend the December Board of Directors meeting. Those newly elected officers will assume their office at the end of the December **Board meeting.**

ARTICLE VII MEETING AND QUORUMS

- Three annual meetings of the organization shall be held: the Annual Banquet in January, the Fish Fry in August and the Pot-Luck in November.
- There shall be regular Board of Directors meetings at a time and place determined by the President. All members in good standing are invited to attend any regularly scheduled Board meetings
- Special membership meetings may be called by the President, three (3) individual Board members or by petition of 18 current voting members.
- A quorum for the purpose of electing officers and amending Bylaws is defined as the number equal to twice the number of the Board of Directors currently in office.

ARTICLE VIII FEES AND DUES

The Board of Directors shall determine the annual Club dues. All or part of the membership dues may be waived for the members of the Board of Directors during the time they shall serve on the Board. The Board shall be authorized to reduce the dues of any member. The Board of Directors may assess additional fees when necessary.

ARTICLE IX FISCAL YEAR

The fiscal year of the organization shall begin January 1st and end December 31st.

ARTICLE X COMMITTEES

The President may appoint special committees for such inquiry and counsel as is necessary, convenient or expedient for carrying out the mission and purposes of the club.

ARTICLE XI TOURNAMENTS

Indoor, field, target and 3-D tournaments or any combination shall be held to determine the Club Champions. Other tournaments shall be held as determined by the Target and/or Bowhunting Coordinators with approval of the Board of Directors.

ARTICLE XII AMENDMENTS

Amendments to the Bylaws may be made by a twothirds majority vote of a quorum at any regular business meeting or special meeting called for that purpose.

ARTICLE XIII

PROCEDURE

The Robert's Rules of Order shall be considered as the standard for procedure at business meetings of the organization.

ARTICLE XIV CLAUSE

- DISSOLUTION
- In case the corporation known as Prairie Bowmen, Inc. is dissolved, all real property shall be placed in the name of a nonprofit charity, or Lincoln City Parks and Recreation, or the Nebraska Game and Parks Commission as determined at such time by the Board of Directors.

TARGET Rep Report

Indoor Target League will start on Tuesday January 8th, 2013, at 7:00 p.m. We will run a 5 week Vegas League and then do a 5 week NFAA League. Cost will be \$6.00 per night, with \$1.00 going into a prize fund. The more shooters we have, the bigger the fund at the end.

Starting on November 1^{st} , all paper targets will cost .50 cents and will be done on the honor system. The target rack will be moved to the front of the range and there is a mail slot on the north wall, where money is to be put. A limited number of targets will be put out, to see if the fees collected correspond with the targets used. Each year, the club goes through 900 - 1,000 targets at the indoor range. As the club is trying to tighten our belts, this is one of the solutions we have come up with.
