# **Privacy Policy**

#### **DATA CONTROLLER**

The danikomunikacija.com website is property of the Croatian Association of Communication Agencies - HURA!, Zavrtnica 17, 10000 Zagreb, tax number (OIB): 97189552878 (hereinafter HURA!).

HURA! pays great attention to the protection of personal data and our Privacy Policy governs the handling of your data while using our services.

## This Policy explains:

- what data we collect,
- what we may do with the collected data,
- whether we share this data with others,
- the type of cookies we use and how you can reject these cookies,
- where we store your data,
- how we keep your data safe,
- your rights regarding your data.

We take protection and processing of your data seriously. We consider that your personal data belongs to you and you alone may decide who to share it with and why. This is fundamental to the way we work and we are committed to providing a secure environment for storing your personal data and sharing it with others when you want it.

## THIS IS THE DATA ABOUT YOU WE MAY COLLECT

## The data you give to us voluntarily

If you register to Dani komunikacija through a registration form, we collect the following data: if you are a student – your first and last name, e-mail address, name of the university and year of study; if you are not a student – your first and last name, e-mail address, information about accommodation at one of the Maistra hotels (if you wish to use the additional discount for registration fee), company name or personal name, address of company or person, company OIB. If you add another participant during registration, we collect the following information about him / her: first and last name and e-mail address, assuming that the persons whose information you share are familiar with it. We collect this information for the purpose of selling registration fees for Dani komunikacija. We may retain this information for five years in the event that you contact us regarding services at Dani komunikacija for any other questions you may have contacted us for or to confirm your participation in the event.

If you apply for IdejaX and Mixx competitions through an application form, we collect the following information about the applicants/buyers and persons involved in the project: company name, address, OIB, first and last name of the contact person, telephone and email address. If you apply for the Effie Croatia competition, information about the data we collect is available in the Effie Competition privacy policy. By registering for the Young Lions competition, we collect the following information: company name, competitor name, e-mail address, mobile number, function and date of birth. We collect this information for the

purpose of registering for competitions and may keep it for 15 years in the event that you contact us regarding the results of the competition.

If you contact us (via email or website), we may keep that conversation for two years in the event that we need to contact you regarding a question that you have asked us to improve operational efficiency and / or manage distressing calls.

If you report a problem with the site, we keep that information for two years in the event that we need to contact you regarding a question that has been addressed to us for the purpose of improving operational efficiency and/or managing harassing calls. We will not use the information for marketing purposes.

The data you provide may include your name, address and e-mail address.

# The data we collect about you and your devices

During your use of the website and our services, we may use technology, such as the one provided by Google Analytics, to collect data about your visit to our website. These tools allow us to analyse the way you and others use our website. The data we collect may include:

- type of browser you are using (e.g. are you using Chrome or Safari),
- number of visits per browser on each device,
- device type (e.g. Samsung) and operating system (e.g. Android) you are using,
- referral information,
- user settings.

When downloading Dani komunikacija app, the Android and iOS app does not collect any information from users.

## WHAT WE DO WITH YOUR DATA WE COLLECT

The data you provide is used for facilitating the provision of services:

- o ensuring that the content on our site is displayed in the most effective way for you and your device to provide easy navigation
- o provide marketing information about us and our services
- o notifications of changes to the website
- o defending our servers against malicious attacks.

#### WHO WE SHARE YOUR DATA WITH

Your data will be shared with other organizations only when we have your permission to do so or there are other legal grounds to do so. We share your data only with our contractual partners and we share only the data necessary for the provision of certain services. All persons who have access to your data and our partners are bound by confidentiality provisions within the framework of contractual relations, and agree to implement organizational and technical protection measures.
