COMMENDATIONS:

The government of Uganda is commended for allocating nearly 10 percent of the total funding need for family planning programs and for having sufficient stocks of contraceptives to meet the country's annual need. It is also commended for publishing key documents online, such as the National and Health Sector Budget Framework Papers, Vote Performance Reports and the National Quantification Report for Public Health Facilities in Uganda. This last document, which provides the annual contraceptives funding need, is noteworthy given that many governments do not make it publicly available.

FAMILY PLANNING BUDGET:

Observations

- The Reproductive Health Items allocation, which combines maternal health and family planning commodities, is 8.5 percent of the total funding need for contraceptives. If half of this budget were allocated to contraceptives, it would mean less than five percent of the total funding need was met.
- The Family Planning Program and Reproductive Health Items allocations are mere fractions of the total health budget, at about 0.4 percent each.
- Since there was no spending on contraceptives due to existing stocks, it is not possible to determine government spending per WRA.

Recommendations

The government of Uganda should prioritize the following actions to strengthen government ownership of family planning:

- Increase funding for both family planning programs and contraceptives.
- Create a Family Planning Program budget line within the Reproductive Health Division in the Ministry of Health budget.
- Create a Familiy Planning Commodities budget line separate from maternal health commodities, within the Reproductive Health Division in the Ministry of Health budget.

TRANSPARENCY:

Observations

- The Family Planning Program budget allocation is found in a document produced for internal use only, and the allocation is not clearly identified in the document.
- Due to the lack of Family Planning Program disbursement data, it is impossible to independently verify whether disbursements were made in the correct amounts and in a timely manner throughout the budget year.
- The lack of Family Planning Program expenditure data means that it is impossible to validate how funds were spent throughout the budget year. It's also not possible to calculate how much the government spent per WRA.
- Although FY 2017/18 ended nearly a year ago, the National Medical Stores Vote Performance Reports for Quarters 3 and 4 are not available on the government's budget website.

Recommendations

The government of Uganda should prioritize the following actions to improve the transparency of family planning budget information:

- Make publicly available online quarterly disbursement and expenditure data for family planning programs.
- Publish quarterly Vote Performance Reports on the government's budget website in a timely manner.
