- 1. Check your account statement for the phone number and website of your account administrator.
- 2. Request or download a beneficiary designation form.
- 3. Designate PAI as a partial, contingent or sole beneficiary of your account.
- 4. Sign and return the form to your plan administrator and keep a copy for your files.

#### SAVE ON TAXES WITH GIFTS FROM A RETIREMENT ACCOUNT

Leaving a gift to PAI through your retirement plan account, such as an individual retirement account (IRA), is one of the most tax-smart gifts you can make. Because most retirement plans are taxed differently than other funds, they may actually become a tax liability if left to loved ones. Because PAI is tax-exempt, we receive 100% of your gift to create your enduring legacy.
