Jessica Tovar - Spoke regarding the EBCPA proposal to support the accelerated decommissioning of Diablo Canyon.

Barbara Stebbins - Spoke regarding A4NR request to revise original Diablo Canyon decommissioning plan to close plant ahead of 2025, citing plant maintenance costs, Surrounding community and PCIA as motivation for the earlier closure

C4. CAC Chair Report (5 minutes)

The Chair informed the committee of the 2020 Meeting Schedule and meeting location rotation for the year.

C5. 2020 PCIA Impacts (15 minutes, CAC Informational Item)

The CAC will hear from staff on the expected changes to the PCIA in 2020 and the potential strategies that EBCE is considering to help mitigate impacts. This will be an abbreviated presentation before discussions on the Carbon Free Allocation item as the two are related. **Presented**

C6. Carbon Free Allocation (40 minutes, CAC Action Item)

Barbara Stebbins - Thanked staff for the clear explanation of the PCIA. B. Stebbins also requested less acronyms for future presentations, timing of allotment and PCIA decisions, and lack of questions asking customers' opinion on nuclear.
