- Not considering the option for accepting nuclear

- State opposition to nuclear usage
- Burden on ratepayers that cannot opt-up to 100% renewable product
- Opposition from Environmental groups
- Agency Reputation risk
- Creating similarities between CCAs and IOUs
- Potential effect on agency power supply viability
- Community Values and opposition to nuclear
- Nuclear plant vulnerability to attack and natural disasters
- Public Health
