



NET ENERGY METERING AND ROOFTOP SOLAR

East Bay Community Energy (EBCE) customers that install new solar or other self-generation technologies are automatically enrolled in EBCE's Net Energy Metering (NEM) program.

Interested in Installing Solar?

A rooftop solar installation can help offset some, or all, of your electricity use. Bill credit for NEM customers is calculated using the retail rate, which is the same rate you would pay to buy that energy.

How it Works

- Under EBCE's service, billing occurs on a monthly basis. If a customer is a net generator in a given month, they accrue generation credits. If they are a net consumer, the credit balance will be applied. If there is insufficient credit balance, the customer is charged for the net amount. For many customers, the monthly billing helps avoid a large yearly true-up charge.
- If at the end of the year your bill credit is positive (meaning that you generated more electricity than you used throughout the year), you will receive compensation from EBCE in April. If your payout is less than \$100, you will receive a bill credit. If your payout is greater than \$100, EBCE will send you a check.
- Customers interested in adding rooftop solar must first apply to PG&E for interconnection approval.

This policy will apply to all NEM rate schedules, including NEM and NEM2.



Electricity

- **Make energy efficiency upgrades to your home.** The Bay Area Regional Energy Network (www.BayRENResidential.org) provides advice, rebates, and other services that will help you reduce your energy bill.
- **Go solar + storage.** Installing solar will add to the renewable generation on the grid while lowering your energy bill. If you include a battery with your solar installation you can reduce emissions further, increase savings, and protect yourself from losing power in the event of a grid shutoff. Transportation
