

RFO Goals

EBCE seeks transactions that will contribute to our greenhouse gas reductions targets outlined in the IRP and our long-term position hedging to address portfolio/risk management, RPS requirements/SB350, and RA

Eligible Products:

- 1. <u>As-Available Product from RPS-eligible resources</u>
 - As-available RPS energy produced by PCC 1-eligible generating resource
- 2. <u>As-Available RPS Product plus Energy Storage</u>
 - Above definition, with co-located energy storage. All energy storage attributes (RA, energy arbitrage, Ancillary Services).
- 3. <u>Stand-alone Energy Storage (tolling PPA)</u>
 - Stand-alone energy storage resource. 2, 4, or 8 hour duration. All storage attributes (RA, energy arbitrage, Ancillary Services).
- 4. <u>Shaped RPS Energy Product</u>
 - PCC 1-eligible energy generated by one or more RPS-eligible resources
- 5. <u>Indexed Energy plus RPS attributes</u>
 - Indexed RPS energy and associated RECs from PCC 1 eligible resources
- 6. Shaped Clean Energy Hedge
 - Minimum 10-year shaped energy hedge delivered by non-GHG emitting resource(s)



Project Characteristics

Facilities:

- <u>Location</u>: Projects may be within or outside of California. All energy must be deliverable to CAISO.
- <u>Construction Status</u>: Energy and related products may come from new or existing resources.

Capacity:

- Minimum Contract Capacity: 10 MW
- Maximum Contract Capacity: 200 MW

Delivery Date:

• Energy and RPS attribute delivery must be within calendar years 2021, 2022, 2023, or 2024, with a preference for projects that begin delivery earlier within this window.

Contract Duration:

5-20 year durations

Technology:

Renewables, Storage, and Large Hydro



Participation

- Robust project offering with over 70 unique project sites and over 400 contract variations
- All 6 products that were solicited were offered
- Offers included solar, wind, geothermal, hydro, and storage
- Projects based in 6 different states, predominantly CA
