## New Staff

# Marketing and Account Services Update

## Time-of-Use Transition

Per California Public Utilities Commission regulation, eligible residential customers In the city of Tracy and other areas of the San Joaquin County and Central Valley transitioned to a Time-of-Use rate with peak hours from 4 PM to 9 PM. The opt-out rate of residential customers in Tracy increased by approximately 0.54% between January (base case) and early May (post-transition). Both PG&E and EBCE will provide bill protection to transitioned customers, meaning each entity will reimburse the customer for any increase in actual payments after one year on the rate as compared to what they would have paid on their previous tiered rate.

A similar transition occurred for residential customers in Alameda County in May 2021. PG&E bill protection credits are showing up on applicable customer bills in May. EBCE bill protection credits will appear on customer bills in June.

## Renewable 100 Default Transitions

Residential customers in Berkeley and San Leandro transitioned to Renewable 100 in March 2022. We are now over one month out from customer transitions and changes in opt out rates remain below the expected target of 0.50%, as shown in the chart below. The cities of Albany, Hayward, and Pleasanton transitioned all customers to Renewable 100 in January 2022, while the city of Dublin transitioned only residential customers to Renewable 100 in that same month.

## New Community Inclusion Update

EBCE staff has completed and presented to Stockton staff the first iteration of Stockton's electricity data analysis. The initial analysis included the following key results:

- Stockton would add approximately 1.34 terawatt-hours (TWh) to the existing EBCE load of 6.45 TWh.
- Stockton load is "peakier" than EBCE's current load. Diversity in the timing of peaks means that the addition of Stockton would not substantially impact EBCE's load distribution throughout the year.

- In 2021, EBCE's "Bright Choice" product would have theoretically reduced Stockton customer expenditures by \$1.49M and increased renewable consumption by at least 6% (80 GWh or enough to power 15,700 homes for a year)
- EBCE CEO and staff met with Stockton's City Manager on May 11. The initial analysis was well received and EBCE staff is working with the City of Stockton staff on next steps
