Tom Kelly stated that S&P had awarded EBCE a credit rating of A, which would bring in investors, but urged EBCE to not contract with investors who are heavily invested in fossil fuels and have not performed well in other areas. Tom Kelly also urged EBCE to not be pressured to put some of its budget surplus into reserve accounts and to use the funds to improve the quality of Bright Choice and reduce rates.

Jessica Tovar, East Bay Clean Power Alliance, spoke regarding the Community Innovation Grants that award funding to nonprofits in EBCE's territory to generate more community innovation. Jessica Tovar emphasized that the Innovation Grants program was intended to be an annual program offered by EBCE and should have its own line item within the budget.

Tom Kelly stated that EBCE guaranteed a discount from PG&E when it was founded, but currently EBCE's generation rates are 3.5% higher than PG&E. Tom Kelly noted that PG&E charges its bundled customers a PCIA charge, which is higher than the one charged to EBCE customers, and EBCE staff has combined generation and PCIA to indicated that the product has been discounted by 1%, but calculating the cost to EBCE

customers based on how that formula was developed reveals that Bright Choice customers are paying millions of dollars more than they should. Tom Kelly requested the BOD require staff to formulate an analysis on rates and emissions intensity compared to the other CCAs in Northern California.

Vaughn urged EBCE to look at how micro-grids can be established in the district and how that would affect the agency. Vaughn noted there is a lot of interest in for-home batteries; however, it is a good idea to put lithium-ion short-term batteries into houses at this stage, because long-term batteries that can hold 24-38 hours will be available in the near future.

Blair Beekman thanked EBCE for trying to keep rates low in the upcoming year, and for trying to address upcoming inflation issues and setting a good example. With respect to Vaughn's comments regarding long-term batteries, Blair Beekman spoke of the need to consider worker rights for people who mine the minerals used in those batteries.
