

## Westfield Club Loyalty Exclusive Promotion Terms and Conditions (the “Terms and Conditions”)

### The Promotion

The Promoter is Westfield Europe Limited (“**Westfield**”), with its registered office at 1 Ariel Way, London, W12 7SL.
