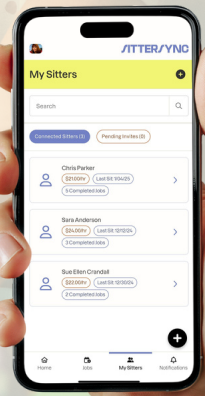

Qualifying Expenses

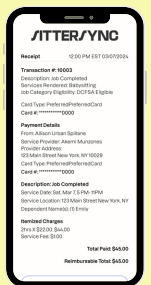
Babysitting services provided so you (and your spouse, if applicable) can work or attend school full-time are eligible for DCFSA reimbursement.

Yes, setup is user-friendly and takes just a few minutes to connect your family and sitters.

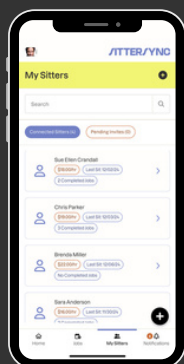
How does SitterSync ensure my data is secure?

The app uses Stripe as its secure payments gateway to protect user data.

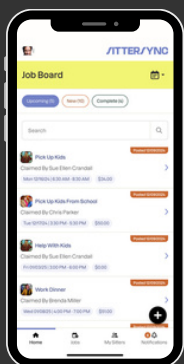
Can I control sitter access to my information?

Yes, sitters only have access to relevant information needed that you add to your profile.

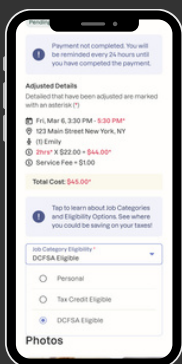

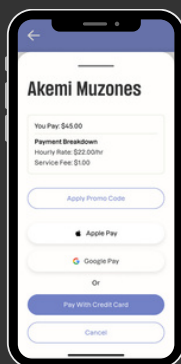
