The above Company Scheme Application No. CA(C.A.A)/33/MB-IV/2025 (the "Company Application") has been filed by the Company before the Hon'ble National Company Law Tribunal, Mumbai Bench ("Tribunal"), inter alia, seeking directions in relation to holding/ dispensing of meetings of its equity shareholders, secured creditors and unsecured creditors to seek their approval to the Scheme of Amalgamation of Dinshaws Snacks and Foods Private Limited ("Transferor Company" or "First Applicant Company") with Dinshaw's Dairy Foods Private Limited ("Transferee Company or "Second Applicant Company") and their respective shareholders and creditors.

The Scheme is an arrangement between the Company and its shareholders as contemplated under Section 230(1)(b) of the Act. Under the Scheme, there is no compromise and/ or arrangement which is in any manner prejudicial to the interests of the creditors. The Scheme does not contemplate any variation in the rights of the creditors of the Company and the liability towards the creditors of the Company is not proposed to be reduced or extinguished under the Scheme. The Scheme will not adversely affect the debt repayment capacity of the Company and the creditors will be paid their dues in the ordinary course of business.

Notice is hereby given that the Hon'ble National Company Law Tribunal, Mumbai Bench ("Tribunal") has vide its order delivered on March 3, 2025 ("Order"), inter alia, directed that meeting of the unsecured creditors of the Company to seek their approval to the Scheme, is dispensed with. Further, by the Order, the Company was directed to serve a notice upon its unsecured Sundry creditors with a direction that they may submit their representations, if any, to the Tribunal and a copy of such representation shall simultaneously be served upon the Company.
