

## § 1 General Provisions

1.1. These Regulations define the rules of the Contest, conducted with the game "The Witcher: Old World - Monster Hunting" (hereinafter referred to as the "Contest").

1.2. The Organizer of the Contest is Games Lab Sp. z o.o., Święty Marcin 24/409, 61-805 Poznań, NIP 7792499880 (hereinafter referred to as the "Organizer"), which is the owner of the Go On Board brand.

## § 2 Conditions of Participation

2.1. Participants of the Contest can be individuals who have reached the age of 18.

2.2. Participation in the Contest is free of charge for participants of the event called Pyrkon.

2.3. Each participant of the Contest is obliged to comply with these Regulations.

## § 3 Rules of the Contest

3.1. The Contest will take place during the Pyrkon event, which takes place on: June 16 - 18, 2023, at the location of the Poznań International Fair in Poznań, ul. Głogowska 14, 60-734 Poznań

3.2. The aim of the Contest is to score points by participating in the Contest. It involves discovering sequences of words on posters placed in different places of the facility where Pyrkon is held.

3.3. Points are awarded for finding word sequences and then assigning them the appropriate point value.

3.4. The Organizer is the administrator of the table with scores.

3.5. The participant must enter the best found sequence into the form on the Contest page.

3.6. To start participating in the Contest, the participant must scan the QR code on the poster and go to the Contest page and follow its instructions.

3.7. The Organizer reserves the right that in case of a tie, the open question asked in the form on the Contest page decides.

3.7.1 Ties will be resolved by a committee composed of selected creators of the board game The Witcher Old World: Łukasz Woźniak and Barnaba Drukała.

3.8. The Contest lasts from June 16, from 9:00 AM, to June 18, until 6:00 PM

## § 4 Submissions

4.1. To participate in the Contest, the participant must fill in the application form on the Contest page, providing their real personal data, and follow its instructions.

## § 5 Prizes

5.1. The prize will be awarded to the winner of the Contest, selected according to the rules described in § 3.

5.2. The prize is intended for the first place in the Contest.

5.3. The prize is:  
a copy of the board game The Witcher: Old World (deluxe version).

## § 6 Safety and Liability

6.1. All posters are placed in publicly accessible places and on terms that do not violate public order.

6.2. Participants are obliged to take care of their safety and not to enter or climb dangerous places.

6.3. The Organizer is not responsible for damages caused or incurred by participants of the Contest.

## § 7 Complaints and Disputes

7.1. Any complaints related to the course of the Contest should be reported in writing to the e-mail address [kontakt@goonboard.com](mailto:kontakt@goonboard.com) within 7 days from the end of the Contest.

7.2. Properly submitted complaints should contain: the participant's name, surname and e-mail address, description of the problem that has arisen and any evidence.

7.3. The Organizer will consider the reported complaints within 14 days from the day of receiving the complaint and will notify the participant of the decision made electronically.

7.4. The Organizer's decision on the complaint is final.

## § 8 Changes in the Regulations

8.1. The Organizer reserves the right to make changes to these Regulations at any time, provided that it does not affect the acquired rights of participants.

8.2. Any changes to the Regulations will be communicated to participants through updating the Regulations on the Contest page.

## § 9 Personal Data Protection

9.1. The administrator of personal data of Contest participants is the Organizer.

9.2. The personal data of participants is processed exclusively for the purpose of conducting the Contest and possible verification of the participant's identity in case of winning.

9.3 In accordance with Article 13 of the General Data Protection Regulation (GDPR) of April 27, 2016 (Regulation (EU) 2016/679), we inform you that your personal data is administered by Games Lab Sp. z o.o., located at Świąty Marcin 24/409 61-805 Poznań, referred to as the Administrator hereinafter.

9.4 Your personal data will be processed by the Administrator for marketing purposes

9.5 The basis for processing this data is Article 6(1)(a) of the GDPR.

9.6 Participating in the Contest is equivalent to giving consent for the processing of personal data in accordance with the Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (OJ EU L 2016 No. 119, p. 1 as amended).

9.7 Your personal data will be stored for an indefinite period.

9.8 You have the right to request the Administrator for access to personal data, rectification, deletion or restriction of processing, the right to object to data processing, the right to data portability and the right to withdraw consent.

9.10. Detailed information on personal data protection is available in the Organizer's privacy policy.

## § 10 Final Provisions

10.1. Participation in the Contest means acceptance of these Regulations.

10.2. In matters not regulated in these Regulations, the provisions of the applicable European Union law and, if necessary, the law of the country of the Organizer apply.

10.3. Any disputes arising from participation in the Contest will be settled by the competent common court.

10.4. The Organizer reserves the right to cancel the Contest, change its rules or withdraw prizes without giving a reason, if the law requires it.
