

## RESPONSIBLE PAPER AND PAPERBOARD SOURCING POLICY

April 2023

DK is the world's leading illustrated publisher and a member of the Penguin Random House division of Bertelsmann, creating cutting-edge design and stunning visual books for the whole family, that explores ideas and nurtures curiosity about the world we live in. With a book loving community of over 800 colleagues in the UK, US, Germany, India, China and Spain, DK produces books in over 60 languages.

As a diverse organisation operating worldwide, we are committed to ensuring all our products are responsibly and ethically sourced and manufactured. This document highlights some of the ways in which we embed this commitment into our procurement practices.

### **EXECUTIVE SUMMARY**

Our responsible paper and board sourcing policy is designed to ensure that only materials that are from known, verifiable and legal sources are used in our products.

- From 1st January 2021 100% of the paper used in our products is Forest Stewardship Council<sup>®</sup> certified and 100% of our paperboard is FSC<sup>®</sup> certified or 100% post consumer waste recycled.
- Prior to this date, materials were risk assessed using the Book Chain Project Forest Sourcing tool; only materials rated 3\* and above may be used.
- Annual spot fibre testing takes place to verify pulp content of paper and board.

All of our manufacturing and paper providers are required to adhere to this policy.

### SUSTAINABLE PAPER SOURCING

DK recognises the vital importance of forests and the services they provide, such as the purification of water and air, raw materials, the promotion of biodiverse ecosystems and a home for indigenous communities. Deforestation and forest degradation not only risks these services, but is a significant source of global greenhouse gas emissions, which contribute to the climate emergency. Our responsible paper and paperboard sourcing policy aims to combat deforestation by supporting and promoting responsible forest management practices.

We achieved our goal of sourcing 100% of the paper used in our products from FSC<sup>®</sup> certified sources, and 100% of our paperboard from FSC<sup>®</sup> certified or 100% post consumer waste recycled sources in January 2021. Prior to this date we purchased a mix of FSC<sup>®</sup> materials along with materials that have been risk assessed and designated as coming from known, legal and responsible sources as defined by the Book Chain Project<sup>1</sup> Forestry Sourcing tool.

As a founding participant in The Book Chain Project, we actively utilise their Forestry Sourcing tool to assess and understand the pulp sources of the papers we use.

DK and our sister company, Penguin Random House UK are FSC<sup>®</sup> certified publishers (<u>FSC-C018179</u>) in the category of Books and Printed Material. We have held this chain of custody since 2006. When producing books in regions outside the US and EU, we comply with applicable laws, including the US Lacey Act, the UK Timber Regulations and the EU Timber Regulations, which ban illegal logging and trafficking of wildlife, including plants and plant products.

# RESPONSIBLE PAPER AND PAPERBOARD SOURCING POLICY

April 2023

### SUPPLIER STANDARDS

We strive to procure paper only from suppliers who source responsibly and all suppliers are required to sign up to the Sustainability Principles set out in our Supplier Compliance Policy. Key points include:

- All suppliers are required to hold ISO 14001 or establish an environmental management system that reflects equivalent standards by the end of 2023.
- All suppliers are asked to establish policies which address climate change and which set ambitions to demonstrably reduce their environmental impact.
- All of our print manufacturing suppliers globally are required to be FSC<sup>®</sup> certified.

### VERIFICATION

Internal controls are in place to ensure that only materials which meet our responsible paper and paperboard sourcing policy can be selected for manufacture. Regular paper usage reports are run by our Procurement Manager to measure and monitor the usage of papers and paperboards.

We require our printers and paper suppliers to avoid any controversial fibre. Working closely with our supply chain, we ask that fibre composition records of the paper they supply are maintained to ensure traceability. To verify that these requirements are consistently met, we conduct fibre analysis sample testing checks and confirm that papers specified on our purchase order have been used in the finished product. We address any discrepancies with our suppliers. Please refer to our <u>Fibre Testing Policy</u> for further details.

### RESPONSIBILITIES AND REVIEW

Overall responsibility for this policy resides with DK's Chief Operating Officer. We are committed to reviewing this policy regularly to ensure that it maintains compliance to evolving legal obligations as well as our high sustainability standards.
