## Introduction:

Places taking part in the NELP CCA evaluation are asked to complete two separate surveys, the Resources survey and the System Maturity survey (see separate [guidance note](#)). NELP will use responses to both of these surveys, together with other data collected, for Configurational Comparative Analysis (CCA). To be included in the CCA evaluation, Places must respond to **both** of these surveys.

**Please note that responses to the Resources survey will be shared with Sport England (SE), but the SMM survey responses will not be shared with SE**, unless the Place partnership representative submitting the response gives explicit permission to share this data. Please refer to the Resources survey Participant Information documents for more information on this.

## What are we evaluating?

NELP is using CCA as part of its evaluation of Sport England's programme of Place-based Systemic Approaches (PBSA) to physical activity. For more information on this work please visit our website - <https://evaluatingcomplexity.org/>.

CCA is a method of systematically comparing multiple cases, or 'Places' to identify patterns of conditions that predict positive outcomes. A '**Place**', for the purposes of this evaluation, is defined as an individual **local authority area** in which a Place-based systemic approach to physical activity is being implemented. While specific areas may be targeted within a borough or city, we are looking at the system conditions across the local authority area as a whole.

A key purpose of the CCA surveys is to help to develop our understandings of:

- the resources available and how they are deployed to enable delivery of the PBSA (Resources survey)
- current system maturity conditions within the Place, including how work undertaken as part of the PBSA may have influenced or changed these (System Maturity survey)

These will be used alongside relevant published data, such as demographics, deprivation levels etc. to create a unique profile of conditions in each Place. By taking part in the CCA work, you enable us to identify patterns, or configurations, which lead to more effective Place-based working and ultimately to longer-term outcomes (see [CCA explainer](#)).

## Purpose of the survey

The purpose of the Resources survey for NELP is to help to develop our understandings of what resources are available within a Place and how they are used. This includes not only financial resources but also the people, their knowledge and skills, policy and organisational contexts.

## Responding to the survey

We ask for a nominated lead (such as programme manager) in each Place (defined as a local authority area) to submit a single response to the Resources survey. They may need to draw on colleagues to provide specific information, and where the response requires a more subjective assessment this should represent the views of a range of people engaged with as part of the process, as far as possible. In some cases, a final judgement call may be required where there are differing opinions. The survey questions are attached at appendix 1 for reference.

**Note:** This survey is about the resources available and utilised to implement a PBSA to Physical Activity inequalities. This includes financial contributions as well as in-kind contributions, such as people's time and expertise, and access to spaces or equipment. Please do **not** include resources relating to ongoing delivery of PA facilities and activities, such as leisure centre staffing. We are looking for your best estimates of the level of funding and other resources, not precise budget figures or staff hours.

#### *How to complete the survey*

NELP will provide a unique link, which will be sent to the lead contact for each Place, enabling them to complete the online survey on behalf of the partnership. Responses are recorded as you progress through the survey, so if you are not completing it in one session, you can use the original unique survey link provided to return to the partially completed survey, from any device. The Place lead may choose to share the link to enable others to contribute to completion, but it is **important to note** that **anyone with the link will be able to see and edit all responses**. Links must not be forwarded to other place partnerships. Once a response has been submitted to the final question, further changes will not be possible using the original link. The NELP team can provide a new link to enable changes if needed, up until the deadline. #### **What happens to our data?**

In submitting the survey response, you will be asked to confirm your consent for this data to be shared with the organisations which comprise the NELP for its evaluation purposes and with Sport England for management information and development of learning support. Places are free to share the information submitted as they see appropriate, in keeping with requirements for data protection and confidentiality.

The NELP team may contact you if we need to clarify any of your responses, and following this, the data will be used in our CCA process in a binary form. This will be used along with your System Maturity survey and published data on contextual indicators, in our configurational comparative analysis. Some of the patterns identified will be shared with Place and SE representatives in 'sense-making' workshops, when we will explore how these relate to local experiences of place-based systemic working and why we might be finding such patterns. The findings of the analysis, including the sense-making workshops, will be made publicly available in learning seminars, summary report form and in academic research papers.
