**RE: The Death of American Citizen Shanquella Robinson in Mexico**

Dear President Biden and Secretary Blinken,

On behalf of the family of Shanquella Robinson, we write to request immediate diplomatic intervention from the United States Government in this transnational criminal case . The case involves the death of Shanquella Robinson, a 25-year- old ambitious, bright, entrepreneur and American Citizen. Shanquella traveled to Cabo San Lucas, Mexico on October 28<sup>th</sup>, 2022 and was reported dead in a luxury Villa in Cabo on October 29<sup>th</sup>, 2022. Her six travel mates<sup>1</sup> returned to the United States the next day. Three of the six travel mates Wenter Donovan, Khalil Cooke, and Daejahnae Jackson would transport Shanquella’s luggage from Mexico to her mother’s home in Charlotte, North Carolina. They would give their condolences and inform Mrs. Robinson that Shanquella passed away from alcohol poisoning.

On November 16<sup>th</sup>, 2022 one of the travel mates shared video from a cell phone camera around the campus of Winston Salem University, the college that Shanquella Robinson attended. The video shows Shanquella being beaten in the villa while naked by one of the six travel mates who was identified by a witness as Dejahanae Jackson<sup>2</sup>. An autopsy report prepared on October 30<sup>th</sup>, 2022 in Mexico by Medical Examiner Dr. Rene Adalberto Galvaan Osegura noted that Shanquella’s body had a head injury <sup>3</sup> and concluded that Shanquella’s cause of death was a broken neck.

After the video of the beating of Shanquella Robinson surfaced online, The Attorney General's Office in Baja California Sur initiated a criminal investigation. As a result of the investigation a

warrant was issued for Daejahnea Jackson by Mexican Law Enforcement, one of the six travel mates who fled<sup>4</sup> to the United States after Shanquella was pronounced dead. Ms. Jackson was identified as the perpetrator of femicide against Shanquella Robinson, a homicide based on gender.

If a United States citizen commits homicide in Mexico and returns back to the United States, as you are aware they can face criminal charges in the United States under federal law or state law, depending on the circumstances of the crime. Federal charges are brought in cases where the crime involves interstate commerce or federal law enforcement agencies. We know in a transnational case where evidence was possibly transported and persons of interest communicated with each other via cellphone federal charges could be brought against those responsible for Shanquella's death.

Under federal law, the most likely charge that could be brought against someone primarily responsible would be a violation of 18 U.S.C. § 1112, which covers manslaughter and involuntary manslaughter. If the individual's actions meet the requirements of murder under federal law, they could also be charged with a violation of 18 U.S.C. § 1111. Federal charges that could be brought against co-conspirators to a homicide include conspiracy to commit murder, aiding and abetting, accessory after the fact and obstruction of justice.

As you are also of course aware, transnational criminal cases can be complex and challenging to resolve, especially when they involve individuals and entities in different countries. We understand each country has sovereignty over its own citizens and that each country has its own legal systems which can create issues. We also understand there is a protocol for the resolution of transnational crimes. Despite reaching out to Consular authorities who are tasked with being the family's guide and liaison in cases such as this we have encountered numerous obstacles in our efforts to receive information for the family on whether those responsible would ever be brought to justice. While on a fact finding mission on behalf of the family, Attorney Sue-Ann Robinson was advised by a member of the United States Consular corps in Mexico that if the family was seeking information about the case perhaps the family should reach out to the at-large travel mates. Certainly this is an unacceptable response to share with an American family in regards to their daughter's murder.

Given the nature and scope of this case, we believe that diplomatic intervention from the U.S. Government could help facilitate the necessary cooperation and coordination between the involved parties to ensure that justice is served timely, that the accused are tried under the appropriate legal system, that extradition is possible, and that international cooperation is fostered.

The United States can follow the extradition protocol and turn over the individual or individuals responsible for Shanquella's death to Mexican Authorities. Alternatively, U.S. federal law enforcement agencies can request concurrent jurisdiction with Mexican law enforcement agencies which would permit U.S. prosecutors to bring the case in the United States as the involved parties are U.S. Citizens. We have just witnessed what a swift concurrent response from Mexican and U.S. law enforcement agencies looks like in the kidnapping case of a group of U.S. Citizens at Matamoros, Tamaulipas Mexico. Both scenarios we are requesting on behalf of Shanquella Robinson's family require a high level of

swift diplomatic intervention.

My clients recognize that the U.S. Government has many priorities and responsibilities, but believe that intervening in this case would not only serve the interests of justice but also send a clear message that transnational criminal activities will not be tolerated.

Thank you for your attention to this matter, and we look forward to hearing from you soon.

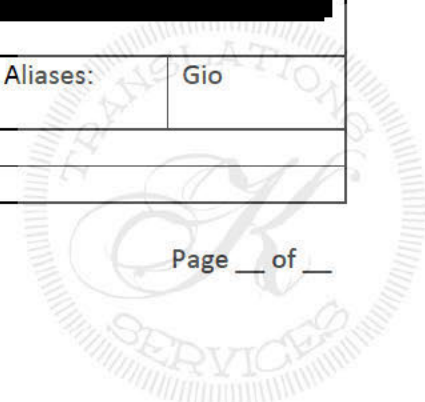

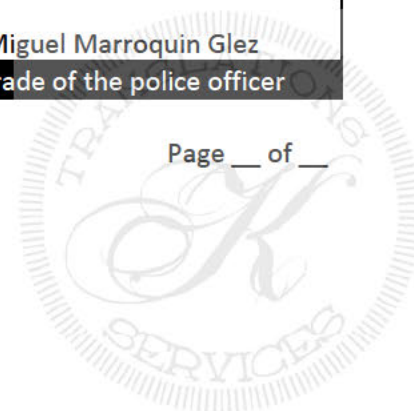
I am the administrator of the villa Casa Linda #32 Colonia La Playa Residencial Puerto Los Cabos, Fraccionamiento Fundadores Beach Club, calle Padre Kino esquina Padre Guillen in San Jose Del Cabo, Baja California Sur, where I have worked for more than a year and a half. Once I observed on my cell phone the video circulating in social networks where two of the guests who had registered in the villa appear, where one of them dressed in pajamas with shorts and blouse, possible colors pink, white with black and a light colored cap, appears hitting another female person who was naked; the one who is hitting the other is the person named Daejhanae Jackson, whom I identify because I served as a translator on the day of the events when the authorities were in the village conducting the proceedings. In the video it can be seen that the headboard is illuminated by the sun's rays, and due to the location of the sun's rays I can deduce that it is between 7:00 and 8:30 am since the bedrooms 1 and 3 are waterfront and it is easy to deduce the morning schedule since the sun rises on the sea side illuminating those rooms; that is the room number 3 because that is the only one that has a hammock outside of it and the hammock can be seen in the video. Also after 10:00 a.m. the sun's rays begin to reflect towards the floor of the bedroom, since there are some pergolas on the outside of the room. I can also say that in that villa both at sunrise and sunset are very annoying, for that reason the owner decided to place wood on the windows to prevent the sun's rays from entering. I know this because I am the administrator of the villa and on many occasions I have been in the rooms at that time of the morning. Finally, I wish to state that the villa was reserved from October 28th to October 31st, 2022, that is all I wish to state.

This is my statement given to investigation agent Suni Jehseel Popoca Millán in reference to the facts that are being investigated today after informing me the reason for my presence and the interview. I have been employed by [redacted] or Cabo Villas in the United States where I work as Concierge, in attention and customer service, I provide service, assistance with doubts, any service that is needed, for approximately three and a half years. On October 28, 2022 I had been informed of the arrival of some guests to the villa Casa Linda 32, which is located in Padre Kino Puerto Fundadores Puerto Los Cabos, San Jose del Cabo and calle Padre Guillen. The day before I was sent the work schedule of the villas that we are to take care of as Concierges, so I knew that the guests of the Casa Linda villa would arrive around 3:00 pm on October 28, 22. The main client was Daejhanae Jackson with phone number + 1-860-888-9330, who contacted me around noon by text message to report that her flight had been delayed due to the weather and that she would be telling me her new arrival time, confirming me that it would be at 17:19 pm. Then she asked me if after arriving and taking the transportation, she could stop to do some shopping, to which I respond that there is no problem; then she told me that she would be letting me know the time they were going to arrive. She texted me when they left the shopping center. She arrived at the Casa Linda villa around 20:00 hours. I had arrived at the villa about 15 minutes before and upon entering I see a person of slim build, Afro-American about 1.75 m tall, about 25-30 years old, to whom I introduced myself, since he asked me who I was. I told him that I am his Concierge and that I will be supporting his vacation in everything he needs. Also at the villa were chef [redacted] and waiter [redacted] who are employees of the company [redacted] and co-workers. Moments before, when I saw the guest, I was surprised, since I wasn't aware that there were guests already at the villa, to which the Chef told me

that two people, a couple, had arrived at the villa a few hours before; however, I only saw the male guest described above. I prepared my registration sheets, the information I have to provide to the client, guacamole, tortilla chips, margaritas and I waited for the main client, who arrived almost immediately in Trascabo's transport. They got off with their groceries, bottles of alcohol and tequila, put down their suitcases, start taking pictures of the villa. They looked excited. In total five people arrived, three women, two of them African American and one between African American and mixed Latino; of them, the main one named Daejhanae Jackson, who is of sturdy build, tall, dark skin, with a thick voice; she was accompanied by two male guests of African American descent, both of slim build; one of them had dreadlocks. I introduce myself to the main guest, Miss Jackson, as her concierge and welcome her. I asked her if she would like to see the villa and show her to her rooms, along with some of her guests or friends to decide who would stay in the rooms. We return to the dining room to sign the documents, which consist of guest registration, insurance included in the villa and residential complex rules, and provide a copy of each one of them, registering the following 1 - Khalil Cook, 2 - Malik Dyer, 3 - Wenter Donovan, 4 - Shanquella Robinson, 5 - Alisse Hyatt, 6 - Daejhanae Jackson, 7 - Nazeer Wiggins [Illegible] Investigation agent Suni Jehseel Popoca Millán in this act. The main guest stayed in the master bedroom, which is located at the end of the living room. There are two rooms and at the end of the kitchen is a TV or entertainment room, then an access with an open area, which connects three more rooms, the first room on the left is waterfront and the other room on the right is also waterfront and the third room which is a double, not waterfront, being this at the end of the garage.

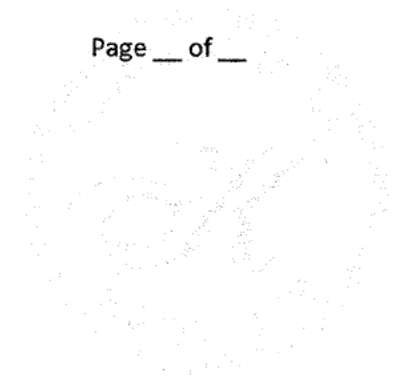

I went to the room of the main client, Mrs. Jackson, to mention to her that dinner was ready since 20 hours and that if it needed to be extended, they would be charged an extra hour, which she did not agree to and sent everyone to dinner, since everyone was settling in her room. Minutes later they all sit at the table and begin to drink a lot; that is when I meet Miss Shanquella, who was the last one to approach the table to celebrate, noticing in her a strange [illegible] attitude, she seemed not to fit in with the others; when I introduced myself she did not greet me or smile, she was indifferent, nothing to do with the atmosphere of celebration. She was out of place at that party. I made sure that they were seated, having dinner, sharing and celebrating, and that they had the information for the Internet, the audio, the operation of the house; once everything was ready I left. All the clients, chef [redacted] with phone number [redacted] and waiter [redacted] with phone number [redacted] stayed in the place. The next day at 13:50 or 13:52 hours I received a text message from the main guest Miss Jackson asking me if I am available and which was the nearest medical service; I greeted her and asked her how I could support her and if she was looking for a hospital; she answered yes, "I think my friend has alcohol poisoning and needs emergency service and someone to speak or translate in Spanish for us" I offered to send her a doctor so he could determine if it was necessary to go to the hospital and I told her that doctor speak English; she answers "Yes, please". I tell her that it costs \$100 for the visit plus the medicine, I ask her if she agrees and she answers "Yes, as soon as possible"; I tell her that I will make the call to request the service to which she answers "Yes, please". Around 2:00 p.m. on October 29, 22 I called Dr. [redacted], who is our contact for medical attention of our guests and whose telephone number is [redacted]

and in about four minutes Ms. Jackson texted me asking me what I had been told and I answer her that a doctor is going to contact her to check her friend, and she replies "OK". Attached to this document is a screenshot of the conversation with Ms. Jackson and I where she asks me for medical help, and the conversation is recorded on three letter-sized sheets of paper attached hereto. At 16:25 [redacted] texted me and told me that the girl has to be hospitalized, because after being evaluated she has to be hospitalized and that her friends were finding out if they had insurance, to which I ask if she is in serious condition and the doctor said no, but that she does need an IV, that she is practically unconscious and that was why she had to be hospitalized. Later the administrator [redacted] [redacted] with telephone number [redacted] called me to ask if I requested an ambulance for the villa; I told him no. He tells me that security of Puerto Los Cabos is asking him about the request and access of an ambulance to Casa Linda number 32. Later [redacted] called me to tell me that the guest had died and asks me to go there as soon as possible, that he is already on his way to help in whatever he can. I went to Puerto Los Cabos from Cabo San Lucas after having spoken with [redacted] Upon arriving at the villa I find a couple of municipal police officers talking to [redacted] in the parking area of the house, and one of the guests who was of African American descent, regular build, short hair, was coming and going from the house, and calling by cell phone a relative or friend in the United States, using [redacted] as a translator. I also saw the main client Ms. Jackson making contact with the male guest and on several occasions entering and leaving the house. During this time I am waiting for [redacted] to tell me what to do, since he are my Concierge team leader, so I enter the house, where I initially observe the guests, relaxed, calm, sitting in the living room area, near the bar and dinner table.

My purpose was to look for the main guest Miss Jackson and give her my condolences; when I talked to her I gave her my condolences, she thanked me and told me that they had talked to her friend's mother and mentioned that this was so fast, "to lose her in an instant for having had too much alcohol". I asked her if I could give her a hug to which she said yes, and she gave me a very indifferent hug, very cold. I saw a very sad guest, a skinny girl, and I saw that she was in pain. I left that area and stayed outside the main entrance to give them space to mourn and grieve; minutes later I heard laughter. I approached [redacted] who told me to leave, to go back to my villas in Cabo San Lucas, that he will be in charge of following up and supporting the clients and the authorities. I said goodbye to the clients and I left for Cabo San Lucas. Later around 21 - 21:30 hours the main guest contacted me to request transportation to go to dinner because they had not eaten anything all day due to the situation, so I called [redacted] with phone number [redacted], who owns Land's End Transfer, requesting transportation for the clients of Villa Linda 32 to San Jose to go to dinner because they had not eaten anything. The driver advised of his departure from Villa Linda 32 to San Jose del Cabo to find a restaurant for dinner. At the end of the service the driver [redacted] with phone number [redacted] reported via audio message on the WhatsApp chat of the Land's End Transfer group that the service had ended and that he had left the guests at the Airport Hotel. The next day [redacted] called me to tell me that the maid was reporting that there was no one in the villa, that if I had been notified that they were leaving, to which I replied that no, that the day before they had only requested transportation to the center; so later around 11:00 in the morning, I sent a message to

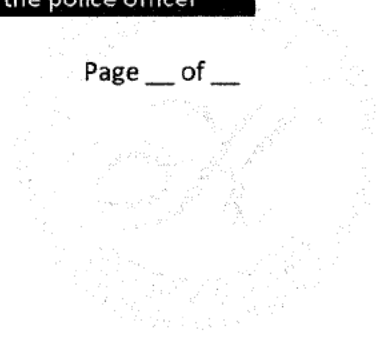

Miss Jackson to offer my support, asking if everything is ok and if there was anything I could do for it; without getting a response until the next day Monday October 31, 2022 when she texted me asking if she had to do anything else for check out, if she had to sign anything I could email it to her as they had already left; later she asked me for the property manager's number so minutes later I sent it to her. Days later I found out that there is a lot of controversy because of the news and the video of the main guest, Miss Daejhanae Jackson hitting her friend Shanquella, the guest who died. When I saw the video in social media I realized that practically the main guest Miss. Jackson had manipulated me with the information she provided of what happened to leave the country as soon as possible. It should be noted that she put the name of Nazeer Wiggins as the last person on the guest list or registry.

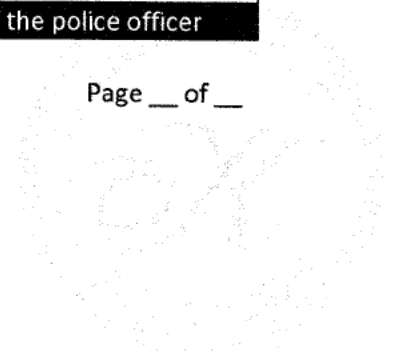

The right eyeball has sclerotic internal hemorrhagic zone of .5 cm.
