Magnesium contributes to electrolyte balance.

INGREDIENTS: Potassium citrate monohydrate, Magnesium citrate; sweeteners: isomalt, sucralose and acesulfame K; S&R CALC® (exclusive blend of Phyllanthus (Phyllanthus niruri L.) aerial parts d.e. tit. at 15% in tannins, and Ceterach (Ceterach officinarum DC) rhizome d.e. E:D 1:4; orange aroma and orange juice powder (on maltodextrin); Hyaluronic Acid (from sodium hyaluronate); acidifying agent: citric acid; anti-caking agents: magnesium salts of fatty acids and silicon dioxide; thickening agent: acacia gum.
