

# REVIVEN®

**INDICATIONS:** REVIVEN® is based on S&R VEN™ (exclusive blend of Melilot, Horse Chestnut and Revifast® (Resveratrol), Vitamin C and Lipofer® (liposomal Iron). Melilot promotes the functionality of venous circulation (Functionality of the hemorrhoidal plexus) and, together with Horse Chestnut also the functionality of the microcirculation. Vitamin C contributes to the normal formation of collagen for the normal function of blood vessels and it also increases the absorption of iron. Iron contributes to the normal formation of red blood cells and hemoglobin.

**INGREDIENTS:** S&R VEN™: blend of (*Melilotus officinalis* (L.) Pall.) Flowering aerial parts d.e. at 20 % in coumarin, Horse Chestnut (*Aesculus hippocastanum* L.) bark d.e. tit. at 15 % in Escin, Revifast® (Resveratrol from bark of *Polygonum cuspidatum* Siebold & Zucc.; bulking agent: Magnesium hydroxide); bulking agents: Cellulose, Cross-linked sodium carboxymethyl cellulose; Lipofer® (Iron pyrophosphate, Corn starch, stabilizing agent: Sunflower Lecithin), Vitamin C (L-Ascorbic acid, bulking agent Ethylcellulose); anti-caking agents: magnesium salts of fatty acids, silicon dioxide and talc; red tablet film coat (Coating agents: Hydroxypropylmethylcellulose, talc, polyethylene glycol; coloring: iron oxides and hydroxides).

**HOW TO USE:** It is recommended to take 1 or 2 tablets a day to be swallowed with water.

**STORAGE CONDITIONS:** Keep the product in a cool and dry place (with temperature not above at 25° C), away from light.

The minimum storage term refers to the properly stored product, in unopened package.
