



REVICOL Food supplement based on Berberine, Red Yeast Rice, Astragalus, Revifast®, an extract of Polygonum and Coenzyme Q10. Astragalus promotes cholesterol metabolism.

INGREDIENTS: Berberine chloride from the bark of the branches of Berberis aristata DC.; bulking agents: cellulose, cross-linked sodium carboxymethylcellulose, acacia gum, corn starch; Revifast® (extract of Polygonum cuspidatum Siebold&Zucc. root; bulking agent: Magnesium hydroxide) tit. min. 30% in Resveratrol; anti-caking agents: magnesium salts of fatty acids, silicon dioxide and talc; Monacolins from red rice fermented with Monascus purpureus; Astragalus (Astragalus microcephalus Willd.) root e.s. tit. 70% in Polysaccharides; Red film: (glazing agents: Hydroxypropyl methylcellulose, Talc. Polyethylene glycol; Colorant: Iron oxides and hydroxides); Coenzyme Q10 (Ubidecarenone).

HOW TO USE: it is recommended to take 1 tablet per day, to be swallowed with water, one in the morning and one in the evening, preferably on an empty stomach.

WARNINGS: Do not exceed the maximum recommended daily dose. Do not consume 3 mg or more of monacolins from fermented red rice daily. It is advisable to seek medical advice before using this product and ask your doctor for advice on consuming this product if you have any health problems. Do not use this product during pregnancy, breastfeeding, in children under 18 years of age or in adults over 70 years of age. Do not use this product if you are being treated with drugs to lower cholesterol, lipid-lowering drugs or if you are taking other products containing fermented red rice. Keep out of reach of children under 3 years of age. Food supplements should not be considered a substitute for a varied and balanced diet and a healthy lifestyle.

STORAGE CONDITIONS: Store in a cool (not exceeding 25°C) and dry place, away from light and humidity. The minimum shelf life refers to the product correctly stored, in an intact package.
