6. Dr Sudhir Peshin, the erstwhile Medical Superintendent assumed the appointment of the Director Medical on 01 April 2020 vice Col (Dr) JP Gupta resigned.

### **PART II: PROGRAMMES**

#### **Covid 19 Pandemic**

8. The Covid19 Pandemic has been the single most impactful event of the year. It had, and continues to have, a debilitating effect on our SE and TB Control programmes.

9. Our primary concern throughout has been, and is, the safety and well-being of our beneficiaries and employees.

10. With the first Covid19 +ve case reported in the Dehradun District on 15 Mar20 we reviewed the situation and decided to, quickly, safely & systematically, close down the SE School & Day Care Centre and TB Hospital facilities until further notice.

11. Commencing 18 Mar 20 all our beneficiaries that could possibly return to their care-givers—50 PwD resident in the hostels and 10 TB patients admitted in the hospital – went home. As a consequence, by 22 Mar 20 RAPHAEL was left with a total of 243 persons – 67 persons in Life-long Care (28 leprosy cured patients; 39 Persons with Disability (PWD) (including 12 children); 41 employees with 135 family members – residing on campus. Employees living off campus were encouraged, unless otherwise stipulated, to ‘work from home’; and all movement in & out of the campus was strictly regulated. A copy of our Covid 19 Pandemic Protocol put into immediate effect is at Enclosure 2.

12. Notwithstanding the above the main office continued to function; employees residing on campus took on the additional administrative workload and; the hospital staff provided medical care to the sick.

13. Thanks to the understanding and support of our benefactors, in particular our institutional donors, we have had the satisfaction of ensuring that all our employees receive their pay and allowances as entitled. In addition, in recognition of their devotion to duty, staff members who bore the brunt of the work-load during the uncertain period of the first nation-wide lockdown were paid a bonus of Rs. 5000.00 each.

14. The cessation of programme related activities on campus has enabled us to carry out long pending and urgent maintenance, repair and renovation work to improve the existing infrastructure. Details of the major civil works planned & carried out during the period are in Part III of this report.

15. As on date a total of 16 persons (11 employees, 02 family members and 03 beneficiaries) have tested +ve for Covid19 and we have had 01 fatality. Their details are at Appendix C. Also, with the assistance of the State *Samaj Kalyan* (Social Welfare) Department, out of a total of 156 eligible persons (18 years of age and above) on campus 108 have been fully vaccinated and 31 have received their first dose.

## **SE Programme**

16. With the PwD at home the challenge was twofold: first, to establish and maintain regular and continuous contact between Special Educators, students and their care-givers; and second, to adapt the means available to individual and small group learning and counselling sessions in an environment where internet connectivity is poor; smart phones are rare; and mobile phones often 'shared' within a family. Under the circumstances it is indeed encouraging that our Special Educators were able to conduct regular online sessions with 93 out of a total 145 PwD

17. Good use of the opportunity has also been made to conduct several in-service training programmes for our Special Educators using virtual means; and for our mobile outreach teams to assist government agencies in identifying, assessing and counselling CwD and their care-givers in the districts of the State.

### **On Campus Activity**

#### **SE School & Day Care Centre**

18. A nominal roll of CwD enrolled in the SE School & Day Care Centre is at Appendix D.

#### **Training Centre**

19. With effect from Oct 20 the erstwhile Rehabilitation Workshop & Weaving Centre has been designated the Training Centre where SE courses, workshops, central events and vocational training of CwD will be carried out.

20. DEd SE (ID) Courses have recommenced on 4 Jan 21 after a lapse of one year during the period 2019-20. The batch wise nominal roll of trainees enrolled in the DEd SE (ID) Courses 2020-22 is at Appendix E.

21. The digest of Training Centre activities aimed at informing, counselling, educating and training Special Educators, staff members, care-givers and stake-holders is at Appendix F.

22. Details of participation by the staff of RAPHAEL in organised external activities are at Appendix G.

#### **Therapeutic Centre**

23. The erstwhile Resource Centre has been converted into a Therapeutic Centre that will provide the following facilities and services under one roof:

- Physiotherapy.
- Speech Therapy.
- Early Intervention.
- School Readiness.
- Sensory Room.
- Resource Room.

24. Details of CwD assessed and listed for various therapeutic activities in the Therapeutic Centre are at Appendix H.

### **Off Campus Activity**

25. Outreach A continues to cover five blocks of the Dehradun District – Raipur, Vikasnagar, Doiwala, Sahaspur and Kalsi. The Block wise nominal roll of CwD enrolled in Outreach A is at Appendix I. A summary of Outreach A activities is at Appendix J.

26. Outreach B covers seven districts of the State of Uttarakhand - Uttarkashi, Tehri Garhwal, Udhamasinghnagar, Haridwar, Pauri Garhwal, Bageshwar and Almora.

27. Between 15 Feb and 31 Mar 2021, as part of Raphael's Memorandum of Understanding (MoU) with Uttarakhand *Sabhi Ke Liye Siksha Parishad* (Education for All) mobile teams from RAPHAEL conducted a series of Counselling Camps in 60 blocks of the above districts and, in addition, the district of Nainital reaching out to approximately for 2384 care-givers. A summary of Outreach B activities is at Appendix K.

### **Tuberculosis (TB) Control Programme**

28. Our TB Control Programme has, of necessity, been on hold this year in view of the threat posed by the Covid19 Pandemic especially to our immune deficient population on campus. In November 2020 with the viral threat having receded somewhat we decided to make a cautious beginning. We put in place a slew of anti Covid19 precautionary measures and using the prescribed protective equipment recommenced our Out Patient Department activities. Only to be confronted by the 'second wave'.

29. Essential data pertaining to the year 2020-2021 is as under:

- No of Patients attended Out Patient Department (OPD) – 371 (to include 60 old cases)
- Breakdown of Patients detected with TB:
  - Pulmonary TB - 34
  - Extra Pulmonary TB (Pleural Effusion) - 01
  - Total - 35
- Patients admitted in Hospital (to include review cases) - 10

When set against the average annual data for three years as under:

- No of Patients attended Out Patient Department (OPD) - 2660 (to include 560 old cases)
- Breakdown of Patients detected with TB:
  - Pulmonary TB - 236
  - Extra Pulmonary TB (Pleural Effusion) - 32
  - Total - 268
- Patients admitted in Hospital (to include review cases) - 308, the figures speak for themselves and are indicative of the adverse impact the pandemic has had on our programme.

30. Extracts of the Revised National Tuberculosis Control Programme – TB Notification Register giving details of patients who have tested +ve for TB during the year are at Appendix L.

## **PART III: ADMINISTRATION & COORDINATION**

### **Brief Notes on Salient Issues**

#### **Extension of Lease (Transfer) of Forest Land – Progress Report**

33. The formal letter sanctioning the extension of lease (transfer) of forest land is still awaited.

34. This is despite the Additional Chief Conservator of Forests, Uttarakhand informing the Additional Chief Conservator of Forests, Government of India that RAPHAEL had “**complied with the conditions**” and requesting that the Government of India “**approve**” the lease (transfer) of forest land to RAPHAEL under the Forest Conservation Act 1980. Government of India Letter No 235/1G-2846 dated 27 July 2020 refers.

35. Apparently, the problem is one of identifying a piece of land for purposes of compensatory forestation. Dehradun District being devoid of suitable land the administration is making an effort to identify suitable land in the district of Tehri Garhwal.

36. It is now understood that the DM Tehri Garhwal has identified the land and accordingly, the Commissioner, Garhwal Mandal, has written to the Secretary, Revenue Department, Government of Uttarakhand to transfer the land identified by DM Tehri Garhwal to the forest department for forestation. DM Tehri Garhwal Letter No 822/24-A.L.C.-2 (2019-2020) dated 04 March 2021 and Commissioner Garhwal Mandal letter No 442/26-4(1(2020-2021)) dated 9 April 2021 refer.

37. Progress in the case is being monitored on a monthly basis.

### **Support Service Functions**

#### **Civil Works**

40. The lull in programme activities provided us the opportunity to carry out essential civil works with a view to reorganise and re-appropriate the existing accommodation to meet functional requirements, extend its 'life', and improve habitability. Following a detailed review, the Governing Council approved of civil works in the following order of priority depending on the availability of funds:

- Major repairs to reorganise and refurbish the TB Hospital.
- Major repairs to reorganise, refurbish and renovate Ava Vihar – The Girls' Hostel.
- Modify, repair and re-appropriate the existing Resource Centre accommodation to establish a multi-purpose Therapeutic Centre.
- Modify, repair and re-appropriate the existing Rehabilitation Workshop cum Weaving Centre to establish a Training Centre.

#### **TB Hospital**

41. The planned civil works in the TB Hospital involved changes in the layout plan to streamline reception, testing and examination of patients; enhance facilities, comfort and privacy in the women's ward; ensure adequate facilities for the duty nursing staff; and cater to the accommodation needs of live-in attendants of the patients admitted in the hospital. Work in the TB Hospital commenced on 05 Aug 20 and was completed on 28 Sept 20. The total cost of the project was Rs 14,04,121.00. Sud-Chemie India Pvt. Ltd extended financial support amounting to Rs 10,00,000.00 for the project for which we are very grateful.

### Ava Vihar – The Girls’ Hostel

42. Ava Vihar was constructed in 1959 and underwent major repairs approximately 40 years ago. The accommodation was in urgent need of repairs.

43. The internal layout demanded alterations to provide for improved functioning, comfort and privacy. Space needed to be appropriated to provide for an infirmary, recreational facilities, hostel staff living and stores. The toilets and bathrooms demanded relocation and renovation with child-proof fittings. The floors, walls and ceilings needed restoration and reinforcement. And, the internal electrical wiring needed to be replaced. Overall there was an urgent need to improve ventilation and lighting in the building. And, anti-termite treatment was essential. The accommodation has undergone a major overhaul. Work started on 24 Sep 20 and was completed on 18 March 21. The total cost of the project amounted to Rs.64, 78,790.00. We are indebted to Ryder Cheshire Australia for the very generous contribution of AUD 1, 15, 000.00 (Rs 60, 32,757.00) from the Singleton Bequest.

### Therapeutic Centre

44. As of now work in the new Therapeutic Centre is in progress. It involves a few internal alterations and adjustments and some ‘tidying up’ at an estimated cost of Rs 3, 43,000.00 and should be done by Aug 21. We would like to thank Mr Raj Kanwar and Ryder Cheshire Foundation New Zealand for their contribution.

### Training Centre

45. The conversion of the erstwhile Rehabilitation Workshop cum Weaving Centre into a Training Centre is a major project the estimated cost of which is approximately Rs.32, 00,000.00. When completed it will include:

- Classrooms (2).
- Vocational training facilities to teach house-keeping duties, cooking, shop-keeping skills.
- Computer Lab cum library.
- *Diya* cum Candle making workshop.
- Covered auditorium for the conduct of central events.

46. This project will be undertaken based on the availability of funds.

### **PART IV: FINANCE**

47. A list of active benefactors that includes government agencies, institutional donors and individual donors both overseas and domestic as on 31 March 2021 is at Appendix O.

48. The audit of accounts for the FY 2020-21 has been delayed owing to the Covid19 Pandemic. Extracts of the Statement of Accounts for the Financial Year 2020-21 (unaudited) are at Enclosure 3.

### **CONCLUDING REMARKS**

#### **Tribute – Patrus Paulus**

49. Patrus Paulus, came to Raphael in 1964 at the age of five. He grew up in The Little White House (LWH). In 1998, after his education he was appointed the ‘Housefather’ of the LWH and subsequently the Superintendent of the Girls’ (Ava Vihar) and Boys’ (LWH) hostels in the SE Programme.

50. Patrus knew RAPHAEL inside out and was the ‘go to’ person for anything even remotely connected with the Society and its past. ‘Patrus *ko poochho*’ (ask Patrus) was the cry every time we were faced with a knotty problem. A competent handyman with his bag of tools he was ever willing to put his shoulder to the wheel. Pleasant and forthright his commitment to RAPHAEL was quite extraordinary. He finally retired on 31 Mar 2021 after a two-year extension. He will be missed and wish him a well-deserved retirement.

## Obituary – Daulat Singh

51. We mourn the loss of Daulat Singh, who came to live in Shiv Sadan in 1966 with his wife Usha. For many years Daulat worked with the then Quartermaster at Raphael. He rode a two-wheeler to go into town to purchase supplies. Daulat read the newspaper from cover to cover every day, and given the opportunity loved making a speech! He enjoyed political discussions. When introduced to visitors at Raphael, Daulat could share a wealth of information on Raphael. He had to be admitted to hospital in Dec 2020 owing to pneumonia but contracted COVID, while in hospital and passed away on 28 Jan 21. He was 84 years old.

**Introduction**

RAPHAEL was founded in 1959 in Dehradun (Uttarakhand) jointly by Group Captain Lord Geoffrey Leonard Cheshire of Woodhall, VC, OM, DSO\*\*\*, DFC and his wife, Baroness Sue Ryder of Warsaw, CMG, OBE. Their mission was all-encompassing – *the relief of suffering*.

RAPHAEL is a duly registered charitable society governed by a Memorandum of Association and Rules and Regulations. It caters to the needs of the economically weaker sections of society in the State of Uttarakhand and the neighbouring districts of North Western Uttar Pradesh.

RAPHAEL provides all its facilities and services at no cost to its beneficiaries and is entirely dependent on its benefactors for financial support.

RAPHAEL is currently the State Nodal Agency Centre (SNAC), Uttarakhand for the National Trust for persons with Autism, Cerebral Palsy, Intellectual Disability and Multiple Disabilities.



### **Vision**

RAPHAEL's endeavour is to alleviate suffering.

### **Core Values**

RAPHAEL seeks to provide a clean, green, secure, safe, and empathetic environment for its beneficiaries. Its core values are:

- Competence.
- Compassion.
- Cleanliness.
- Safety & Security.
- Economy.
- Partnering with its benefactors – individual, institutional and governmental.

### **Mission**

RAPHAEL's mission is to assist in the:

- Rehabilitation of children with intellectual and associated disabilities;
- Control of Tuberculosis (TB);
- Life-long care of persons with disabilities who are rejected by society.

### **Programmes**

Currently, RAPHAEL strives to fulfil its mission through three thematic in-house programmes as under:

- Special Education;
- TB Control;
- Life-long Care.

### **Special Education (SE)**

The objective of the SE Programme is to generate awareness about Persons with Disability (PwD) through advocacy; identify and assess children and young adults with intellectual & other developmental disabilities (such as, but not limited to Autism, Cerebral Palsy & Down Syndrome); educate & train children with disabilities (CwD) to realize their potential and facilitate their rehabilitation in the family and community.

SE activities are carried out both on and off campus.

The focus on campus is on functional academics; language and communication skills; and the acquiring of daily living, house-hold, domestic & vocational skills. The emphasis, throughout, is on 'inclusive' learning and activity.

On campus facilities and services include:

- Assisted independent living in a simulated 'home' environment for young adults – separately for 4 girls & 4 boys.
- Residential facilities, separately for 56 girls & 56 boys.
- SE School cum Day Care Centre with a capacity for 150 CwD. This includes class rooms, a library, a computer laboratory and vocational training facilities.
- Therapeutic Centre that provides physiotherapy, speech therapy, psychological assessments and counselling, school readiness and early intervention services; and a Resource room that provides suggestions, ideas and information for persons with special needs to enable them to participate fully in all aspects of living.
- Training Centre for the conduct of professional courses and in-house training of resource persons, stake-holders and members of the staff.

The Outreach Programme (in rural areas) constitutes our off campus SE activities. The programme is bifurcated into an Out-reach Type A (Out-reach A) and Out-reach Type B (Out-reach B). Outreach programmes are closely coordinated with the civil administration. Outreach A has permanent staff members allotted in location whereas Outreach B is conducted by deploying mobile teams comprising staff as required from RAPHAEL.

The focus of Out-reach A is increasing awareness about disability related issues; care-giver counselling & empowerment; and assessment & programme implementation. Out-reach A currently covers five blocks – Raipur, Vikasnagar, Sahaspur, Kalsi and Doiwala - in the Dehradun district.

The focus of Out-reach B is advocacy - increasing awareness about persons with disability; educating resource persons and stake-holders; and the collection, collation and sharing of information and data of PwD for use by various government and non-government agencies. Out-reach B has covered eight districts - Udhamasinghnagar, Uttarkashi, Tehri Garhwal, Haridwar, Bageshwar, Nainital, Rudraprayag, and Pauri Garhwal. It seeks, eventually, to cover all 13 districts of the State in a phased manner.

### **TB Control**

The objective of the TB Control Programme is to assist the Uttarakhand State Government in the control – detection, diagnosis and treatment – of TB.

RAPHAEL is a government designated Directly Observed Treatment Short Course (DOTS) Centre. Its TB Control Programme is run in accordance with guidelines laid down in the Revised National Tuberculosis Control Programme (RNTCP).

Its facilities include a 20 (12 male; 8 female) bed hospital; an Out-patient Department; and a clinical laboratory capable of the full range of investigations for TB. Patients detected with TB are registered and given a unique *NIKSHAY* Identity Number. Those who are able to return to their homes are provided with a ‘referral’ & free medication for a limited period. They are then instructed to report to their local DOTS centre to continue with their treatment in accordance with the RNTCP. Only those patients suffering from acute tubercular infection & ‘shared symptoms’ and deemed unfit to travel are admitted in the hospital. They are discharged with a referral & medication only after their general condition improves. It is this latter ‘in-patient’ facility that makes RAPHAEL’s TB control programme unique.

Whereas medicines for the treatment of TB are provided by the district medical authorities free of cost the expenditure incurred on supportive treatment (to include diet) of patients admitted in the hospital is borne by RAPHAEL.

### **Life-long Care**

The objective of the Life-long Care Programme is to provide a life of dignity to Persons with disabilities.

The Life-long Care Programme is a legacy of the past. When RAPHAEL first started it began by caring for Leprosy Cured Patients (LCP) rescued off the streets. Over the years, the civil administration has found it convenient to entrust RAPHAEL with the care of other PwD who have nowhere to go.

Their custody makes it obligatory for RAPHAEL to acquire legal rights of guardianship in each case and provide each individual with the necessities of accommodation, food, clothing, medical care and, where possible, occupational therapy.

### **Governing Council**

A Governing Council constitutes the “governing body of the Society”. It is responsible for the “supervision of the work of the Society and the management of its affairs”. It comprises 12 elected and 2 ex-officio members. It meets every quarter.

The elected members of the Council are citizens of Dehradun. They represent a cross section of professions – social work, academia, business, law, medicine, finance, civil services & the Armed Forces. The ex-officio members are the Commandant, Military Hospital, Dehradun and the District Chief Medical Officer, Dehradun.

Governing Council members are not in receipt of any kind of remuneration for the services they render.

## **Funding**

Assured long term funding poses a significant challenge to the Society.

RAPHAEL is entirely dependent on its benefactors – government agencies; institutions; and individuals - for the funding of its activities.

Government Financial aid is strictly limited, often delayed and erratic. Overseas foundations in the UK, Australia and New Zealand that have, in the past, contributed generously to the cause are now compelled to draw-down their support. And, domestic institutional support is yet to gather steam.

RAPHAEL solicits the support of its institutional benefactors for its programmes. Pledging support to a programme over a sustained period as opposed to the unwieldy practice of 'restricted giving' enables the flexible use of resources for the betterment of a scheme as a whole; growing the corpus to enhance the Society's self-sustainability; and planning for the future.

From its individual benefactors it seeks contributions to its General Fund, and 'sponsor an individual' & 'sponsor a meal' schemes.

Benefactors, both individual and institutional, also have the option of contributing to RAPHAEL's corpus. Where a single 'one time' contribution is in excess of Rs 10 lakh the Society is obliged to invest and preserve the capital amount under a unique fund head and use only the derived interest to support activities that are mutually agreed.

RAPHAEL is the recipient of the following awards:

- 2011 - National Trust declared Raphael as the 'Best NGO in 2011' for work in the field of Autism, Cerebral Palsy, Mental Retardation and Multiple Disability.
- 2012 - National Society for Equal Opportunity for the Handicapped (NASEOH), India awarded Raphael the Sulakhana Ram Janam Pandey Award.
- 2012-13 - Raphael awarded a Certificate in the medium category for India NGO Award organized by Resource Alliance and supported by Rockefeller Foundation and EdelGive Foundation.
- 2014 - Mrs Priyo Lall, Director Special Education, awarded the Rajiv Gandhi Manav Seva Award for the year 2014 by the President of India.
- 2017 - Spirit of Humanity Regional Winner Award in field of disability in North Zone.

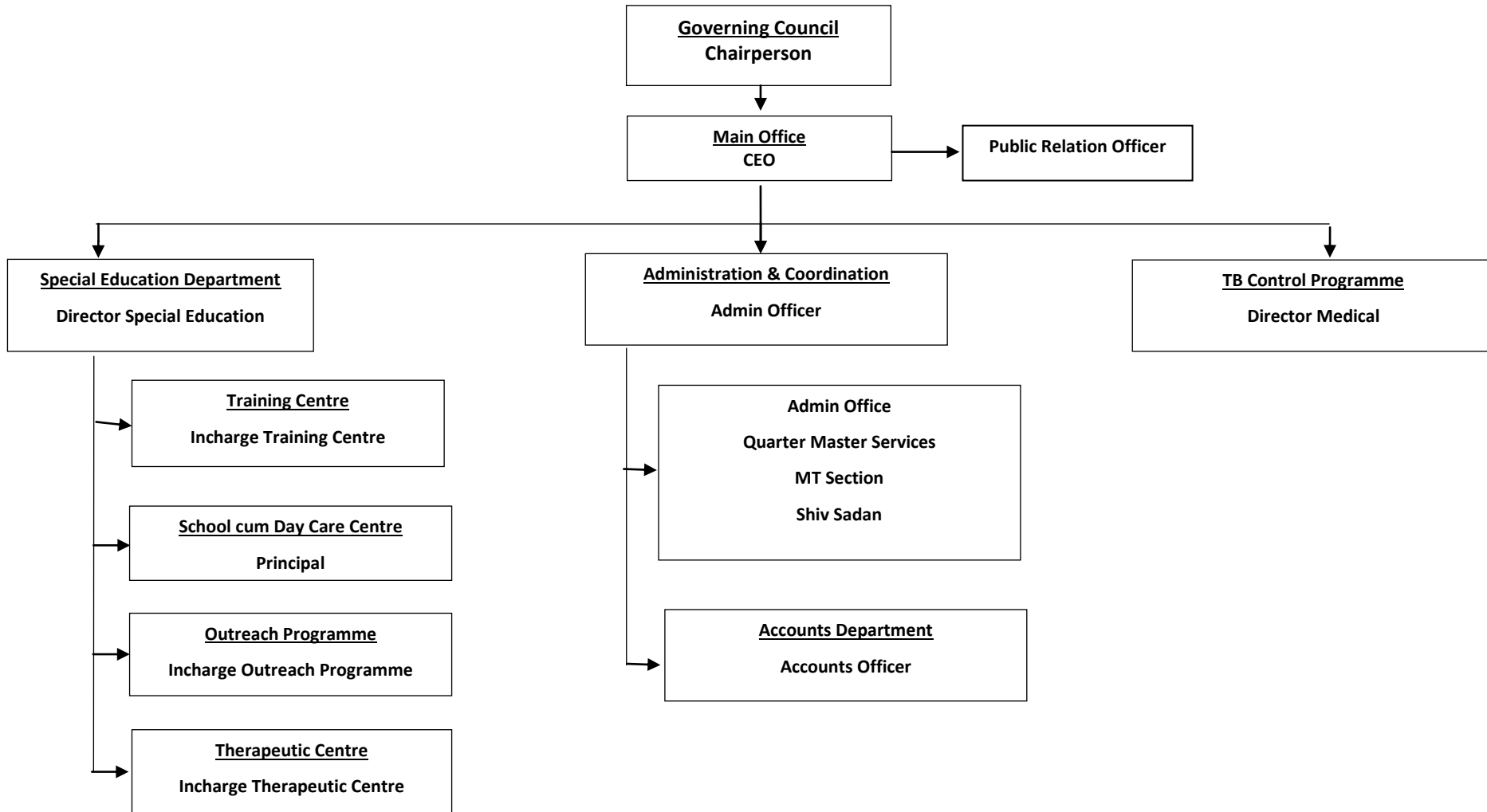

## **RAPHAEL - COVID19 PANDEMIC PROTOCOL**

### **Entry/Exit Protocols**

Main Gate open timings for all residents on Campus will be from 0700 to 1000 hours daily. Any person stepping outside the campus during Main Gate Closed timings will obtain the specific permission of the Admin Officer before doing so.

RAPHAEL security staff on duty at the main gate will wear face masks and will sanitise their hands using soap & water/hand sanitiser at frequent intervals.

Security staff on duty at the Main Gate will ensure all persons – residents; staff members; service providers; vendors and visitors – entering the Campus adhere to the following rules:

- Thermal screening: any person with a body temperature of 37.4\* C will NOT be allowed entry.
- Hand sanitisation.
- Wearing of face mask.

Raphael employees residing outside but permitted to attend their duties in the campus are advised to avoid physical contact with the residents.  
Spitting is strictly prohibited.

### **Motor Transport (MT) Protocol**

MT Drivers will sanitize their vehicles once a day using 1% sodium hypochlorite solution. The inside of the vehicle including keys, steering wheel, gearshift, door handles etc will all be wiped down after each use of the vehicle.

### **Accommodation Sanitisation Protocol**

All accommodation on campus including residential accommodation will be sanitized twice every week, i.e. Mondays and Fridays, using the prescribed Sodium hypochlorite spray.

### **Protocol for Employees on Campus**

All employees on campus will:

- Fill in a Self-declaration Medical Form and are encouraged to download the Arogya Setu App.
- Wear a face mask at all times.
- Maintain a 2m physical (social) distance at all times.
- Ensure frequent hand sanitisation with soap and water/hand sanitiser.
- Wear your mask at all times when on the campus.
- Maintain 2m distance at all times.
- Refrain from spitting.
- Avoid close contact with residents.
- Avoid touching common surfaces.
- Be in possession of your own hand sanitiser, tissues, cup, water bottle, food etc. There will be no common use of the kitchen till further notice.

If you feel unwell at work please stay where you are and inform the Admin Officer telephonically immediately. The isolation room on campus is above the garages.

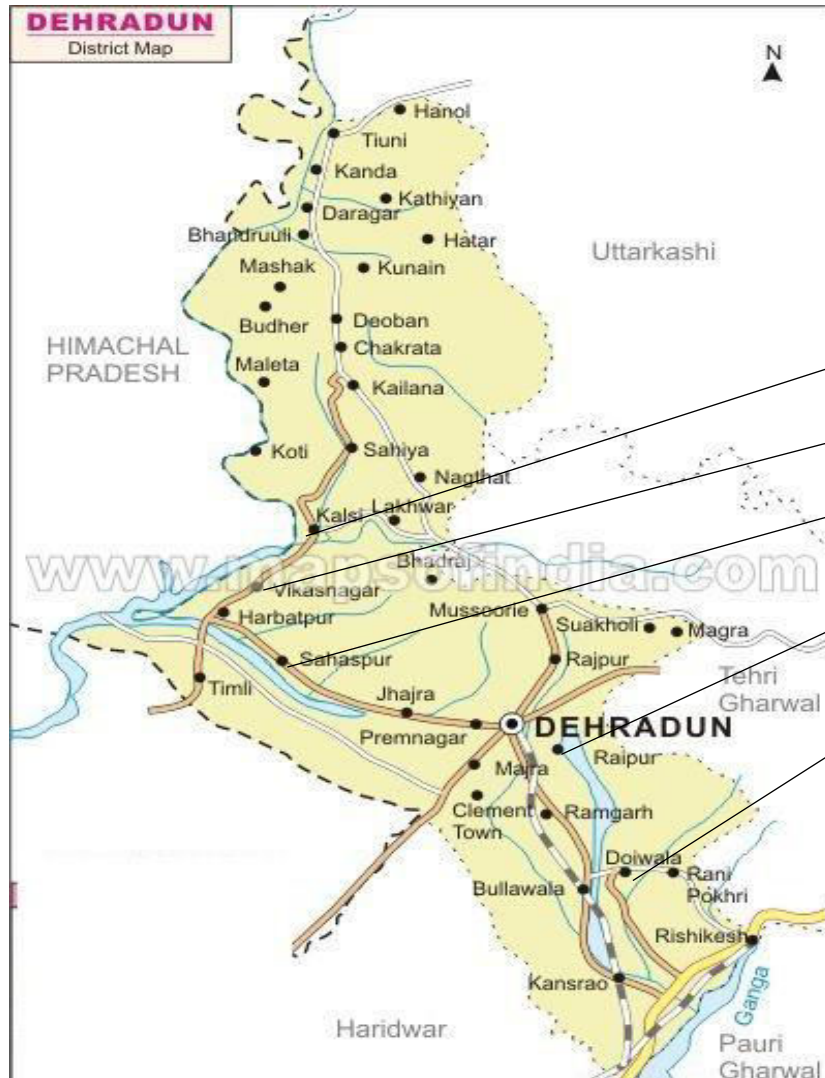

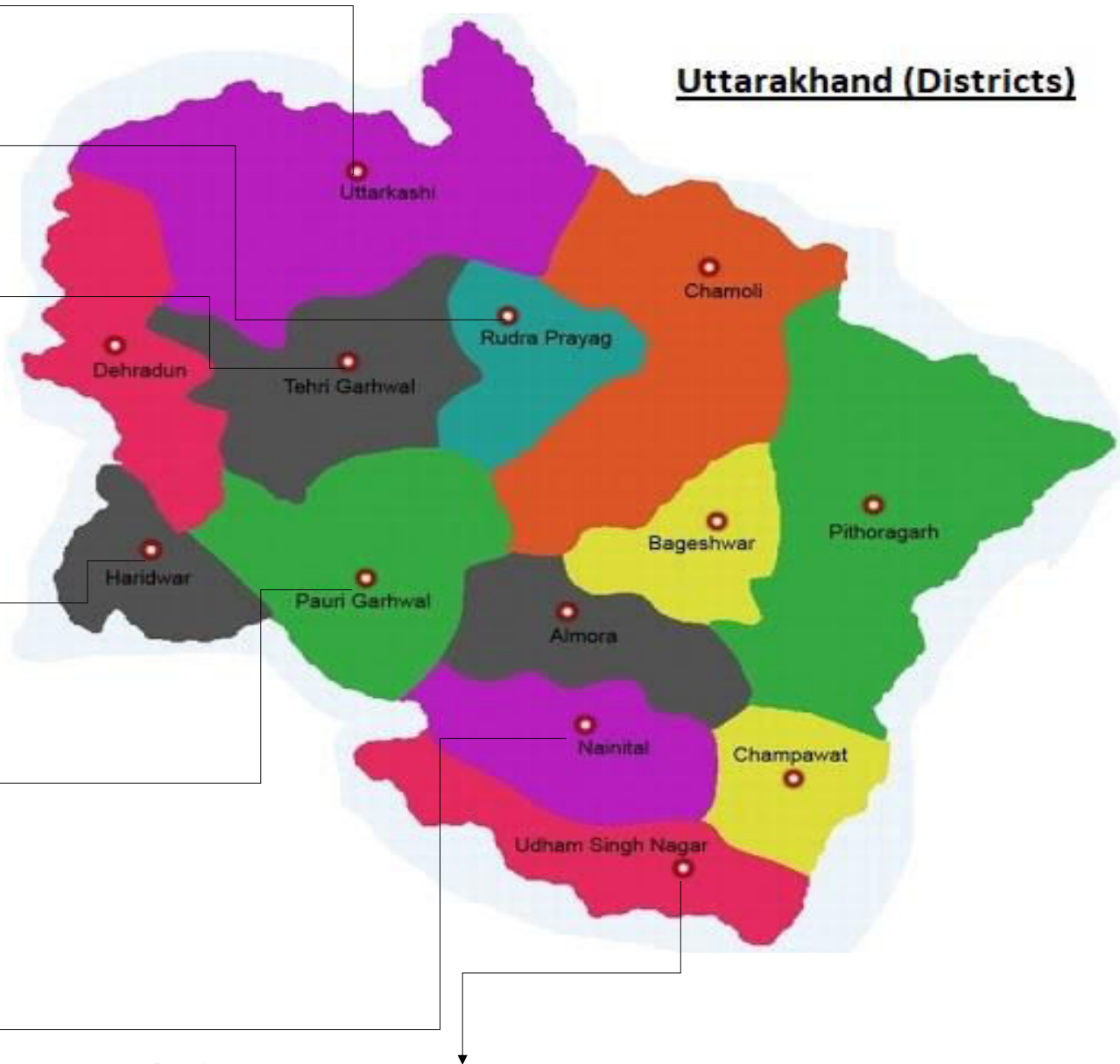
