## **Higher Education Emergency Relief Fund Report**

Under the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA), and the American Rescue Plan (ARP), Universal Technical Institute (UTI) received relief funds to distribute as emergency financial aid grants to eligible students of our institution. Consistent with guidance received from the U.S. Department of Education we are making the following information available regarding the process we have used to distribute those funds to students with exceptional need, and the status of our efforts as of December 31,2021.

• The method UTI used to determine which students receive emergency financial aid grants and how much they would receive under the CRRSAA and ARP programs.

In order to be eligible to receive an emergency financial aid grant at UTI under the CRRSAA or ARP programs, a student must:

- Be a UTI student (including an approved leave of absence);
- Have completed a Free Application for Federal Student Aid and have an approved ISIR on file with UTI;
- ➤ Have an EFC between\$0-\$5,576; and
- > Be a United States citizen or eligible noncitizen as determined by the FAFSA.

Award amounts are determined by each student's financial need, as demonstrated by their <u>Expected</u> <u>Family Contribution (EFC)</u> and the student's proximity to campus. Student grant awards range between approximately \$1000 and \$2300.

• Instructions, directions, or guidance provided by the institution to students concerning the emergency financial aid grants.

UTI has established a website with information concerning the emergency financial aid grants.

• The total amount of emergency financial aid grant funds received by each UTI institution (as defined by the U.S. Department of Education).
