

### 2025-2026 UTI Caribbean Natural Disaster Grant Program

# Universal Technical Institute Grant Amount: \$2,000

#### Objective:

In an effort to provide tuition assistance to students directly impacted by the natural disasters that devastated the Caribbean Islands in 2019, 2020, and 2022, Universal Technical Institute is sponsoring a grant program for incoming students who seek to enroll at Universal Technical Institute.

#### Criteria for awarding the grant:

This grant program is available to enrolled students who were residing in a designated area impacted by the Puerto Rico Earthquakes, Tropical Storm(s) or Hurricane(s) of 2019, 2020, and/or 2022 at the time of declaration. In order to be eligible to apply, all applicants must meet all other admissions requirements for Universal Technical Institute in addition to all of the criteria outlined below.

#### **Program Exclusions:**

- This grant excludes Covid-19 related declarations
- The UTI Caribbean Natural Disaster Grant cannot be used in conjunction with the UTI Natural Disaster Grant

#### Students must:

- Be enrolled to start UTI with a start date between October 1, 2025, and September 30, 2026.
- Have been a resident of a designated area impacted by the 2019, 2020 and/or 2022 Puerto Rico Natural Disasters at the time of declarations
- Submit the completed application to the UTI Scholarships & Grants Department prior to starting classes at UTI.
- Must utilize grant and start classes at Universal Technical Institute within one year of grant award.

<u>Process and Rules:</u> This grant program is available starting October 1, 2025, through September 30, 2026. Students must complete an application and submit it to the UTI Scholarships & Grants Department. For all applicants, the deadline for receipt of the application is the day before your start date. Based on application volume, a minimum of five (5) grants will be awarded monthly on a first come, first served basis. All eligible applications will be reviewed by the UTI Scholarships & Grants Committee, and all applicants will be notified of grant outcome within 48 hours of application submittal. This grant is ONLY available to incoming students. Students already attending classes at UTI are ineligible to apply.

<u>Grant Utilization Rules:</u> The UTI Caribbean Natural Disaster Grant Program will be awarded as a two-part grant for a total amount of \$2,000. Eligible recipients will receive a waiver for both lab and/or meter/equipment fees based on the program selected upon enrollment to Universal Technical Institute. The cost of both the lab and/or meter/equipment fee will be reduced from the initial \$2,000 grant awarded. The remaining balance will be applied to the recipient's account as an internally funded grant. Grant awarding guidelines provided below.

Students who apply and meet all grant requirements but are denied due to monthly funding availability, are eligible to reapply during the following month as long as it is before their start date. All incoming application will be reviewed for eligibility, and there is no guarantee that a grant will be awarded in the next review cycle. The UTI Caribbean Natural Disaster Grant Program cannot be used in conjunction with the UTI Natural Disaster Grant Program. Only one award of this grant will be given per student. Students must be enrolled to attend Universal Technical Institute at the time of application submission. Grants awarded are not transferable to any other person. This grant is considered an internal tuition reduction and has no cash value. All internal tuition reductions are pro-rated over the time a student is in school. If a student chooses not to attend UTI prior to the deadline or, after beginning their program chooses to leave for any reason (withdrawal, suspended, terminated), they will forfeit any unused portion of the award. All grants awarded through this program can only be used during the initial enrollment; any unutilized funds cannot be applied to a secondary account/enrollment.

Grants shall not be used as a recruiting device. Funding for this program is limited, and the program may be suspended at any time at UTI's discretion. Such a suspension will not affect students who are awarded a grant under this program prior to the suspension date.
